The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to ***Azim Cold Storage & Ice Factory** having consumer **Reference Number 30 26113 0000800 U** located at Cold Storage & Ice Factory Road, Peshawar. This Concurrence is being issued in lieu of the earlier Concurrence dated April 18, 2025 to incorporate the enhancement in the capacity from 247.05KW to 300.120KW. However its term of seven (07) years will remain the same and expire on 17th day of April 2032.

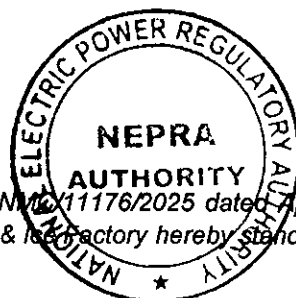
