The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to \*Sami Ullah having consumer Reference Number 30 26233 0006801 U located at Nihal Pura Jehangira District Nowshera. This Concurrence is being issued in lieu of the earlier Concurrence dated October 09, 2024 to incorporate the enhancement in the capacity from 74.340 KW to 160.180 KW. However its term of seven (07) years will remain the same and expire on 08th day of October 2031.
