The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to **\*Bismillah Jan** having consumer **Reference Number 30 26216 0169611 U** located at Kausar Engineering (Pvt.) Ltd. Plot No.186-A, Industrial Estate, Jam Road, Peshawar. This Licence is being issued in lieu of the earlier Licence dated October 13, 2021 to incorporate the enhancement in the capacity from 240.480 KW to 494.420 KW. However its term of seven (07) years will remain the same and expire on 12<sup>th</sup> day of October 2028.
