The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to \*Zahid Anwar having consumer **Reference Number 30 26161 0405122 R** located at Marble Factory at Pir Bala Warsak Road, Peshawar. This Concurrence is being issued in lieu of the earlier Concurrence dated September 20, 2025 to incorporate the enhancement in the capacity from 60.320 KW to 150.80 KW.
