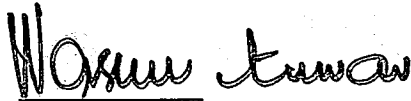
The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to *Tehkadar Khan having consumer **Reference Number 30 26153 0001203 R** located at Marble Factory Subhan Khawar Shabqadar. This Concurrence is being issued in lieu of the earlier Concurrence dated August 12, 2025 to incorporate the enhancement in the installed capacity from 77.400 KW to 90.000 KW. However its term of seven (07) years will remain the same and expire on 11th day of August 2032.

2. The beneficiary shall abide by the provisions under the A&RE Regulations, as amended from time to time.
