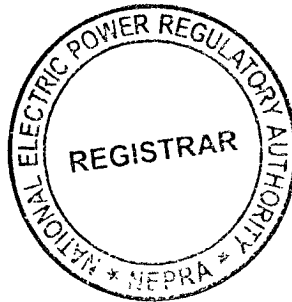


**Reference:** Your application vide letter No. SEL/DT/3864, dated February 24, 2015 (received on March 02, 2015).

**(A). Background**

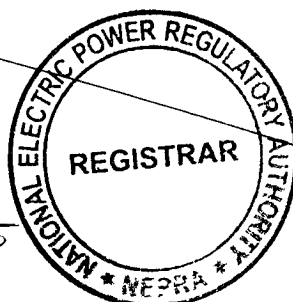
(i). The Authority granted a Generation Licence No. SGC/012/2002, dated January 02, 2002 (and subsequent Modification-I dated December 12, 2013) to Sitara Energy Limited (SEL) in terms of Section-15 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 ("the NEPRA Act").

(ii). The Authority also allowed SEL a Second Tier Supply Authorization (STSA) for supplying electric power to sixteen (16) Bulk Power Consumers (BPCs) in terms of Section-22 of the NEPRA Act and Rule-7 of the National Electric Power Regulatory Authority Licensing (Generation) Rules, 2000 ("the Rules").

(iii). At the time of grant of the above mentioned Generation Licence, the Authority gave SEL an option to either hand over its distribution facilities to concerned DISCO i.e. Faisalabad Electric Supply Company Limited (FESCO) or apply for a Distribution Licence. SEL opted the later option and the Authority in terms of Section-20& 21 of the NEPRA Act, also granted SEL a Distribution Licence No. 12/DL/2006, dated October 20, 2006.

**(B). Submission of Modification**

(i). In accordance with Regulation-10 of the NEPRA Licensing (Application & Modification Procedure) Regulations, 1999 ("the Regulations"), SEL communicated a Licensee Proposed Modification (LPM) in its above



mentioned Generation Licence on March 09, 2015.

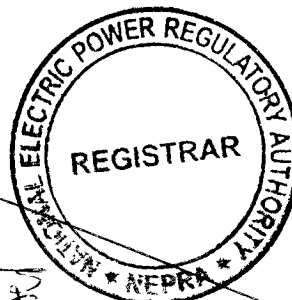
(ii). In the "Text of the Proposed Modification", SEL submitted that it intends enhancing the installed capacity of its generation facility from 49.15MW to 87.82 MW. Further, another twenty two (22) BPC(s) are also proposed to be added to be supplied electric power from the generation facility.

(iii). Regarding the "Statement of the Reasons in Support of the Modification" SEL submitted that its generation facility is located in Faisalabad which is the industrial hub of the Country. New industrial units are being set up however, these industrial units are facing acute shortage of electric power, as FESCO is unable to meet the demand of such industrial units. In view of the said, the industrial units are approaching SEL to provide electric power. There is surplus electric power available with SEL, for supplying to such units. In view of the said, it is imperative for SEL to get the modification in its existing Generation Licence.

(iv). Regarding the statement of "the Impact on Tariff", "Quality of Service (QoS)" and "the Performance by the Licensee of its obligation under the Licence", SEL has informed that it will sell power to BPC(s) on mutually agreed rates therefore, there will be no impact on the tariff. Further, SEL submitted that the proposed addition will not have any adverse impact on the QoS and performance of its obligations under the Generation Licence.

**(C). Processing of Modification**

(i). After completion of all the required information as stipulated under the Regulation-10 (2) and 10 (3) of the Regulations by SEL, the Registrar accepted the LPM as required under the Regulation-10 (4) of the Regulations for further processing.



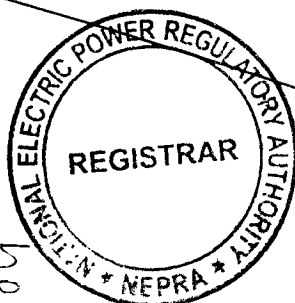
(ii). The Registrar published the communicated LPM in one English and one Urdu daily Newspaper on March 29, 2015, informing the general public, about the modification and for submitting their views/comments in the matter.

(iii). Apart from the above, separate letters were also sent to Government ministries/ their attached departments, representative organizations and individual experts, inviting their views and comments for the assistance of the Authority.

**(D). Comments of Stakeholders**

(i). In response to the Notice of Admission, the Authority received comments from sixteen (16) stakeholders within the stipulated time. These included MK-Sons (Private) Limited (MKSPL), Central Power Purchasing Agency (CPPA)/National Transmission and Despatch Company (NTDC), Abdullah Traders (ATS), Faisal Mustafa Textile Mills (Private) Limited (FMTMPL), Jamal Textile Industries (Private) Limited (JTIPL), Nawab Spinning Mills (Private) Limited (NSMPL), Ghulam Rasool Textile Mill Limited (GRTML), All Pakistan Cotton Power Looms Association (APCPLA), The Faisalabad Chamber of Commerce & Industry (FCCI), All Pakistan Textile Processing Mills Association (APTPMA), Habib Haseeb Spinning Mills (Private) Limited (HHSMPL), Ahmad Din Textile Mills (Private) Limited (ADTMPL), Samira Fabrics (Private) Limited (SFPL), Sui Northern Gas Pipelines Limited (SNGPL), FESCO and Ministry of Petroleum & Natural Resources (MoP&NR). The salient points of the comments offered by the above mentioned stakeholders are summarized in the following paragraphs:-

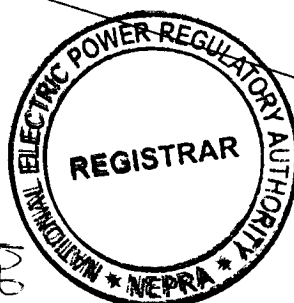
(a). MKSPL commented that it has set up an export oriented textile unit and its plant is ready for operation subject to the availability of electric power. The company has approached SEL for getting electric power which awaits approval of the Authority. Therefore, the request of SEL for enhancing the capacity may be considered at the



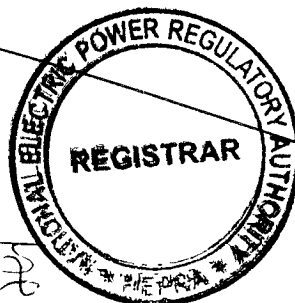
earliest to avoid losses to the project due to delayed execution;

- (b). CPPA/NTDC expressed that it has no reservations on the communicated LPM of SEL. However, SEL should meet all the concerned conditions laid down in the Rules and the consent of FESCO;
- (c). ATS informed that it is a spinning yarn producing unit and requires uninterrupted power supply. ATS has approached SEL for purchasing electric power from it;
- (d). FMTMPL stated that its unit is producing export quality home textile products. In order to fulfill export targets, it wants to get connected with the system of SEL;
- (e). JTIPL informed that it is an exportable weaving grey cloth producing unit. However, it is unable to meet the export targets due to insufficient electric power supply from FESCO. The situation is hampering the production. JTIPL wishes to get electric power from SEL;
- (f). NSMPL expressed that it is running a knitting unit, but it cannot meet production targets due to load shedding from Distribution Company. NSMPL stated that SEL is the best substitute for getting a stable, reliable and continuous electric power;
- (g). GRTML commented that it is a yarn producing unit and needs connection from SEL as it will be providing a smooth and un-interrupted electric power;

- (h). APCPLA remarked that due to load-shedding, FESCO is unable to supply electric power to the industrial units in its area. Whereas, SEL has surplus power and enough resources for future expansion of the power plants. Therefore, application for the modification of Generation Licence may be considered;
- (i). FCCI endorsed the comments of APCPLA;
- (j). APTMA supported the comments of APCPLA;
- (k). HHSMPL mentioned that it is located near SEL and it desires to get connected to SEL;
- (l). ADTMPL submitted that its textile plant can produce yarn but due to non-availability of electric power, it is hard to complete the production targets. In order to overcome this situation, ADTMPL plans to get its electric supply from SEL;
- (m). SFPL commented that it is producing fabrics of exportable quality. However, it is finding difficulties to meet its export targets due to severe load shedding. SFPL expressed that to get a sustained and uninterrupted power supply it requires a connection from SEL;
- (n). SNGPL commented that captive power gas connection was provided to SEL for self-use only. NOC was not issued in favor of SEL for selling of surplus power to DISCO(s). SNGPL expressed that it believes that the subject Generation Licence pertains to power generation of 49.15 MW, which is being enhanced to 87.82 MW



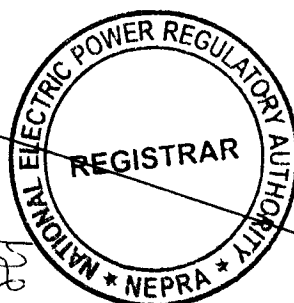
based on furnace oil engines. In such a case, SNGPL has no objection to the modification in Generation Licence based on fuels other than natural gas;

(o). FESCO remarked that SEL has stopped supplying to it after serving a short notice which is contrary to its claim in its statement of reasons in support of the modification. FESCO mentioned that SEL will require getting its Distribution Licence amended if it desires to add new BPC(s) in its system. FESCO contested that, all BPC(s) are also the consumers of it therefore, SEL may not be required to make sale of electric power to a BPC which has contracted from another supplier. FESCO added that the BPC will either stop purchasing of power from it or will convey its intention through a notice three years before such stoppage. The consent of the said consumers as per provisions of the NEPRA Act is missing with the application. FESCO also contested that it has exclusive right to provide distribution services and to make sale of electric power to the consumers in its service territory specified in its Distribution Licence. FESCO suggested that a public hearing may be conducted prior to the subject modification;

(p). MoP&NR endorsed the comments offered by SNGPL.

(ii). The Authority examined the comments of the stakeholders and found that most of the stakeholders had supported the communicated LPM except FESCO and SNGPL. Therefore, the Authority considered it appropriate seeking the perspective of the Licensee/SEL on the observations of FESCO and SNGPL.

(iii). In response to the comments of FESCO, it was submitted by SEL that it helped FESCO in retaining its consumers by supplying it around



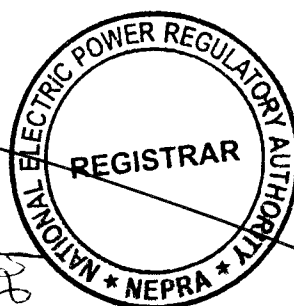
25.00 MW. However, FESCO did not get the Power Purchase Agreement (PPA) renewed despite several requests of SEL. Accordingly, SEL cautioned FESCO through various letters and reminders that in the absence of any long term PPA, it will not be possible for SEL to operate its generation facility at continuous loss. The non-responsive attitude of FESCO has compelled SEL to stop the electric power supply in March 2015. About modification in its Distribution Licence, SEL informed that the same is contingent upon the approval of modification in the Generation Licence. Therefore, the instructions of the Authority pertaining to modification in Distribution Licence if so required will be complied with once the decision on the approval of LPM in Generation Licence is communicated. SEL also rejected the assertion of FESCO that all the proposed BPC(s) are its consumers.

(iv). Regarding comments of SNGPL, the Licensee/SEL clarified that gas connection from SNGPL is purely for captive purpose and is used for supplying to its group companies/sister concerns only and not for the sale to any other BPC.

(v). The Authority considered the above comments of the stakeholders and the rejoinder of SEL and found the same adequate. In view of the above clarifications, the Authority considered it appropriate to process the communicated LPM of SEL as stipulated in the Regulations and the Rules.

#### **(E). Approval of LPM**

(i). As explained at Para (A) above, the Authority granted SEL a Generation Licence No. SGC/012/2002, dated January 02, 2002 to SEL. The Authority had also allowed SEL an STSA for supplying power to (16) sixteen BPC(s) in terms of Section-22 of the NEPRA Act and Rule-7 of the Rules. Further, through Modification-I dated December 12, 2013, the Authority also allowed SEL to supply to FESCO. As explained at Para-(B) above, the current modification of SEL pertains (a). Enhancement in the Total Installed Capacity of the generation facility from 49.15 MW to 87.82 MW and (b). Addition of more BPC(s). In this regard, SEL originally requested for allowing supplying to (22)



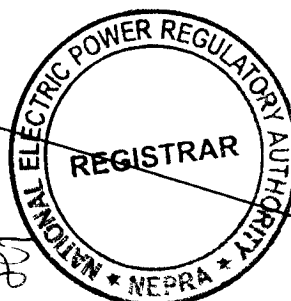


twenty two BPC(s) in addition to its existing. However, SEL decided to restrict the number of BPC(s) to thirteen (13) during the course of the processing of the modification.

(ii). In consideration of above, the Authority is well aware that presently there is severe shortage of electricity in the country and there is huge Supply-Demand gap. In view of this, the Distribution Companies are facing difficulties in serving their consumers. Due to the prevailing situation, the Industrial Units are forced to make their own arrangements to meet their electricity requirements. In view of the said, the Authority considers that the initiative/proposal of SEL/the Licensee of installing/adding more generation capacity to meet with the demands of the BPC(s) is plausible.

(iii). About the request of SEL/the Licensee for supplying to thirteen (13) new consumers, it is clarified that while granting the original Generation Licence to the Licensee/SEL, the Authority had allowed it supplying to sixteen (16) BPCs existing at that time. The said restriction was based to safeguard the interests of DISCOs for making them viable to meet with their Universal Service Obligations. However, with the passage of time, DISCOs are finding it hard to serve their existing as well as prospective BPCs. The huge Supply-Demand gap is forcing the DISCOs to carry out load-shedding in their area of supply. In consideration of the said, the Authority is of the considered opinion that in the prevailing supply constrains imposing such restrictions will not be prudent. Therefore, the Authority hereby revokes the condition for generation companies/Small Power Producers-SPPs for adding more BPCs and allows the Licensee/SEL supplying to new BPC(s).

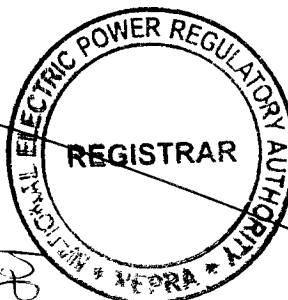
(iv). In consideration of the above, it is clarified that the Authority is empowered in terms of the Section-26 of the NEPRA Act read with Regulation-10 of the Regulations to modify any licence. Regulation-10(5) of the Regulations outlines the criteria for modifying any licence subject to and in accordance with such further changes as the Authority may deem fit if, in the opinion of the Authority such modification (a). does not adversely affect the performance by



the licensee of its obligations; (b). does not cause the Authority to act or acquiesce in any act or omission of the licensee in a manner contrary to the provisions of the NEPRA Act or the rules or regulations made pursuant to the NEPRA Act; (c). is or is likely to be beneficial to the consumers; (d). is reasonably necessary for the licensee to effectively and efficiently perform its obligations under the licence; and (e). is reasonably necessary to ensure the continuous, safe and reliable supply of electric power to the consumers keeping in view the financial and technical viability of the licensee.

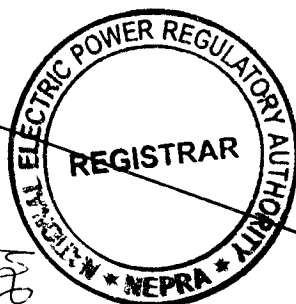
(v). The Authority considers that the current modification of SEL (a). does not adversely affect the performance of SEL of its obligations. The LPM has not caused the Authority to act or acquiesce in any act or omission of the licensee in a manner contrary to the provisions of the NEPRA Act or the rules or regulations made pursuant to the NEPRA Act. The modification is likely to be beneficial to the consumers as uninterrupted electric power will be available to the BPC(s). In fact, the modification is reasonably necessary for SEL to effectively and efficiently perform its obligations under the licence. Further, the modification is necessary to ensure the continuous, safe and reliable supply of electric power to the consumers keeping in view the financial and technical viability of SEL/the licensee.

(vi). The Authority has considered the comments of FESCO as explained at Para-(D)(o) above, making certain observations including (a). SEL may not make sale of electric power to existing BPC(s) of FESCO; (b). BPC(s) intending to stop purchasing electric power from FESCO must convey its intention through a notice three years before such stoppage; (c). The consent of the BPC(s) as per provisions of the NEPRA Act is missing with the application; (d). FESCO has exclusive right to provide distribution services and to make sale of electric power to the consumers in its service territory specified in its Distribution Licence; (e). a public hearing may be conducted prior to the approval of modification; and (f). SEL will be required getting its Distribution Licence amended if it desires to add new BPC(s) in its system.



(vii). In consideration of the above, the Authority clarifies that pursuant to Section-21 of the NEPRA Act, a generation company may make sales of electric power to BPC(s) within the exclusive territory of Distribution Company-DISCO. In consideration of the said, the request of SEL to allow supplying to additional thirteen (13) BPC(s) is in line with the provisions of the NEPRA Act. With regard to three (3) years notice requirement for the BPC(s) as pointed out by FESCO, it is clarified that the same is required if a BPC intends to stop purchasing power from a Distribution Company. However, in this particular case, the prospective BPC(s) having connection from FESCO have confirmed that they do not have any intention to disconnect supply from DISCO. In fact, these BPC(s) will be purchasing the high priced electricity from SEL only, once the supply from FESCO is not available to them. Therefore, in view of the scenario of load shedding, the proposed arrangement for BPC(s) to have a connection from SEL is justifiable. On the observation of FESCO that a Public Hearing may be conducted, it is pertinent to mention that according to the Regulations, there is no such requirement in the case of LPM, except where the Authority intends to modify a licence and the licensee does not agree to the Authority Proposed Modification. Further, the Authority will like to reiterate that due process has been followed as envisaged in the Regulations. Regarding the observations of FESCO that SEL will be required getting its Distribution Licence amended the Authority agrees to same and direct SEL to apply for modification in Distribution Licence once, the decision on approval of LPM in Generation Licence is communicated to SEL.

(viii). The Authority is satisfied that SEL/the Licensee has complied with all the requirements of the Regulations pertaining to the modification. Accordingly, the Authority in terms of Regulation-10(11)(a) of the Regulations approves the communicated LPM without any changes. Accordingly, the already granted Generation Licence (No. SGC/012/2002, dated January 02, 2002 and subsequent Modification-I dated December 12, 2013) in the name of SEL is hereby modified. The changes in "Face Sheet", "Articles of the Generation Licence", "Schedule-I" and "Schedule-II" of the Generation Licence are attached as annexures to this determination. The grant of the LPM will be subject to the



provisions contained in the NEPRA Act, relevant rules framed there under, terms & conditions of the Generation Licence and other applicable documents.



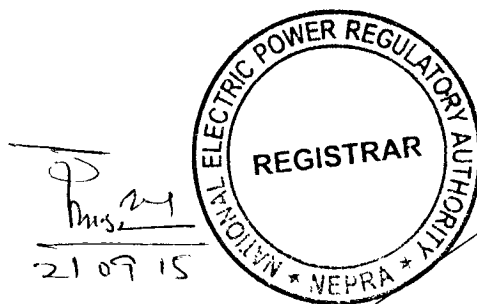

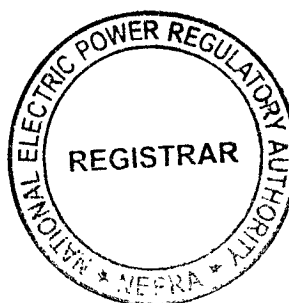
In exercise of the Powers conferred upon under Section-26 of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997, the Authority hereby modifies the Generation Licence No.SGC/012/2002 dated January 02, 2002 and Modification-I dated December 12, 2013 granted to **Sitara Energy Limited** to the extent of changes mentioned as here under:-

- (a). **Changes in Articles** of the Generation Licence attached as **Revised/Modified Articles** of the Generation Licence;
- (b). **Changes in Schedule-I** attached as **Revised/Modified Schedule-I**;
- (c). **Changes in Schedule-II** attached as **Revised/Modified Schedule-II**.  
and
- (d). **Changes in Second Tier Supply Authorization** attached as **Amended/Revised Second Tier Supply Authorization**.

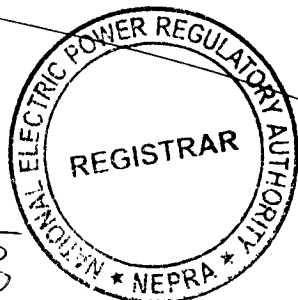




**Article-1**  
**Definitions**

**1.1 In this Licence**

- (a). "Act" means the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL of 1997);
- (b). "Authority" means the National Electric Power Regulatory Authority constituted under section-3 of the Act;
- (c). "Bulk Power Consumer" bears the meaning as defined/contained in determination/decision of the Authority for grant of generation licence to SPP(s) dated October 03, 2002;
- (d). "Co-Generation Power Plant" means the generation facility for simultaneous production of both electric power and heat or steam for industrial processes from a common fuel source;
- (e). "Distribution Company-DISCO" means "a company to whom the Authority has granted a distribution licence under Section 20-21 of the Act and engaged in the distribution of electric power.
- (f). "Licensee" means Sitara Energy Limited and its successors or permitted assigns;
- (g). "FESCO" means Faisalabad Electric Supply Company Limited and its successors or permitted assigns;
- (h). "Power Purchaser" means any BPC which purchases electricity from the Licensee, pursuant to a Power Purchase Agreement for procurement of electricity;



- (i). "Power Purchase Agreement" means the power purchase agreement, entered or to be entered into by and between the Power Purchaser and the Licensee, for the purchase and sale of electrical power/energy generated by the generation facility, as may be amended by the parties thereto from time to time;
- (j). "Regulations" means "National Electric Power Regulatory Authority Licensing (Application & Modification Procedure) Regulations, 1999 as amended or replaced from time to time";
- (k). "Rules" means "the National Electric Power Regulatory Authority Licensing (Generation) Rules, 2000";
- (l). "Service Territory" means the service territory as defined in the distribution licence of FESCO; and
- (m). "Small Power Producer-SPP" bears the meaning as defined in the distribution licence of FESCO.

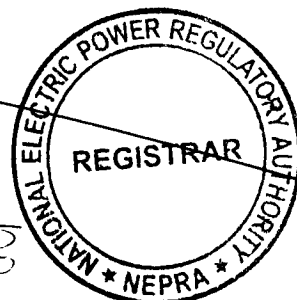
1.2 Words and expressions used but not defined herein bear the meaning given thereto in the Act or in the Rules.

## **Article-2** **Application of Rules**

This Licence is issued subject to the provisions of the Rules, as amended from time to time.

## **Article-3** **Generation Facilities**

3.1 The location, size (capacity in MW), technology, interconnection arrangements, technical limits, technical functional specifications and other details specific to the power generation facilities/Co-Generation Power Plant of the Licensee are set out in Schedule-I of this Licence.



3.2 The net capacity of the generation facilities/Co-Generation Power Plant of the Licensee is set out in Schedule-II hereto.

**Article-4**  
**Term of Licence**

4.1 This Licence is valid from the date of its issue (i.e. January 02, 2002) and will remain valid for a term of fifteen (15) years from the said date.

4.2 Unless suspended or revoked earlier, the Licensee may within ninety (90) days prior to the expiry of the term of the Licence, apply for renewal of the Licence under the Regulations.

**Article-5**  
**Licence fee**

After the grant of the Generation Licence, the Licensee shall pay to the Authority the Licence fee, in the amount and manner and at the time set out in the National Electric Power Regulatory Authority (Fees) Rules, 2002.

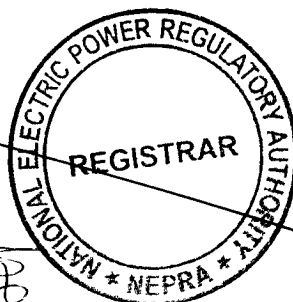
**Article-6**  
**Tariff**

The Licensee shall charge only such tariff which has been determined, approved or specified by the Authority in terms of Rule-6 of the Rules.

**Article-7**  
**Distribution Facilities of Licensee**

7.1 The Licensee may hand over ownership and control of its distribution facilities to the DISCO in whose service territory the Licensee is operating on terms and conditions as approved by the Authority.

7.2 In the case, Licensee wishes to retain ownership and control of its distribution facilities; it shall apply for a distribution licence within one month from the grant of this Generation Licence, in accordance with the relevant NEPRA rules.





**Article-8**  
**Connection to Transmission System, Compliance with Grid Code,**  
**Pooling and Settlement Arrangement**

Rule 10 of the Rules shall apply only to those SPPs whose generation facilities are connected directly or indirectly at voltage of 132 KV or above.

**Article-9**  
**Generating Capacity Reserve Requirements**

The installed generating capacity of the Licensee shall not fall below 85% of the connected load and generating capacity of the largest installed unit of the Licensee.

**Article-10**  
**Compliance with Performance Standards**

The Licensee shall comply with the relevant provisions of the National Electric Power Regulatory Authority Performance (Generation) Rules, 2009 as amended from time to time.

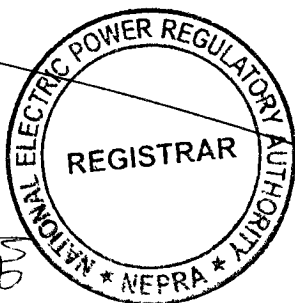
**Article-11**  
**Compliance with Environmental Standards**

The Licensee shall comply with the environmental standards as may be prescribed by the relevant competent authority from time to time.

**Article-12**  
**Maintenance of Records**

12.1 For the purpose of sub-rule (1) of Rule-19 of the Rules, copies of records and data shall be retained in standard and electronic form and all such records and data shall, subject to just claims of confidentiality, be accessible by authorized officers of the Authority.

12.2 The Licensee shall keep complete and accurate record and data in respect of all aspects of the generation business and the second-tier supply business, in their original as well as in electronic form.

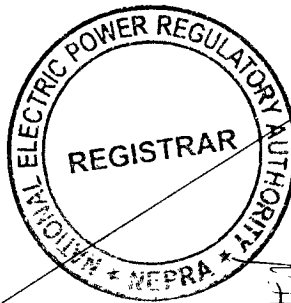


12.3 Without prejudice to the provisions of sub-rule 15(3) of the Rules, unless provided otherwise under the law or the applicable documents, all record and data shall be maintained for a period of five (5) years after the creation of such record or data. The Licensee shall not destroy or dispose off any such record or data after the aforesaid period without thirty days prior written notice to the Authority. The Licensee shall also not dispose off or destroy any record or data which the Authority directs the Licensee to preserve.

**Article-13**  
**Provision of Information**

13.1 The obligation of the Licensee to provide information to the Authority shall be in accordance with Section 44 of the Act.

13.2 The Licensee shall be subject to such penalties as may be specified in the relevant rules made by the Authority for failure to furnish such information as may be required from time to time by the Authority and which is or ought to be or have been in control or possession of the Licensee.

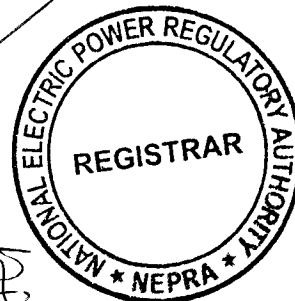

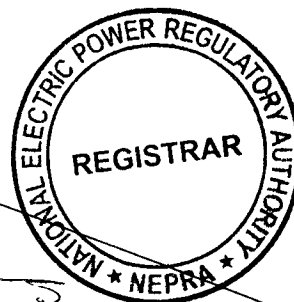
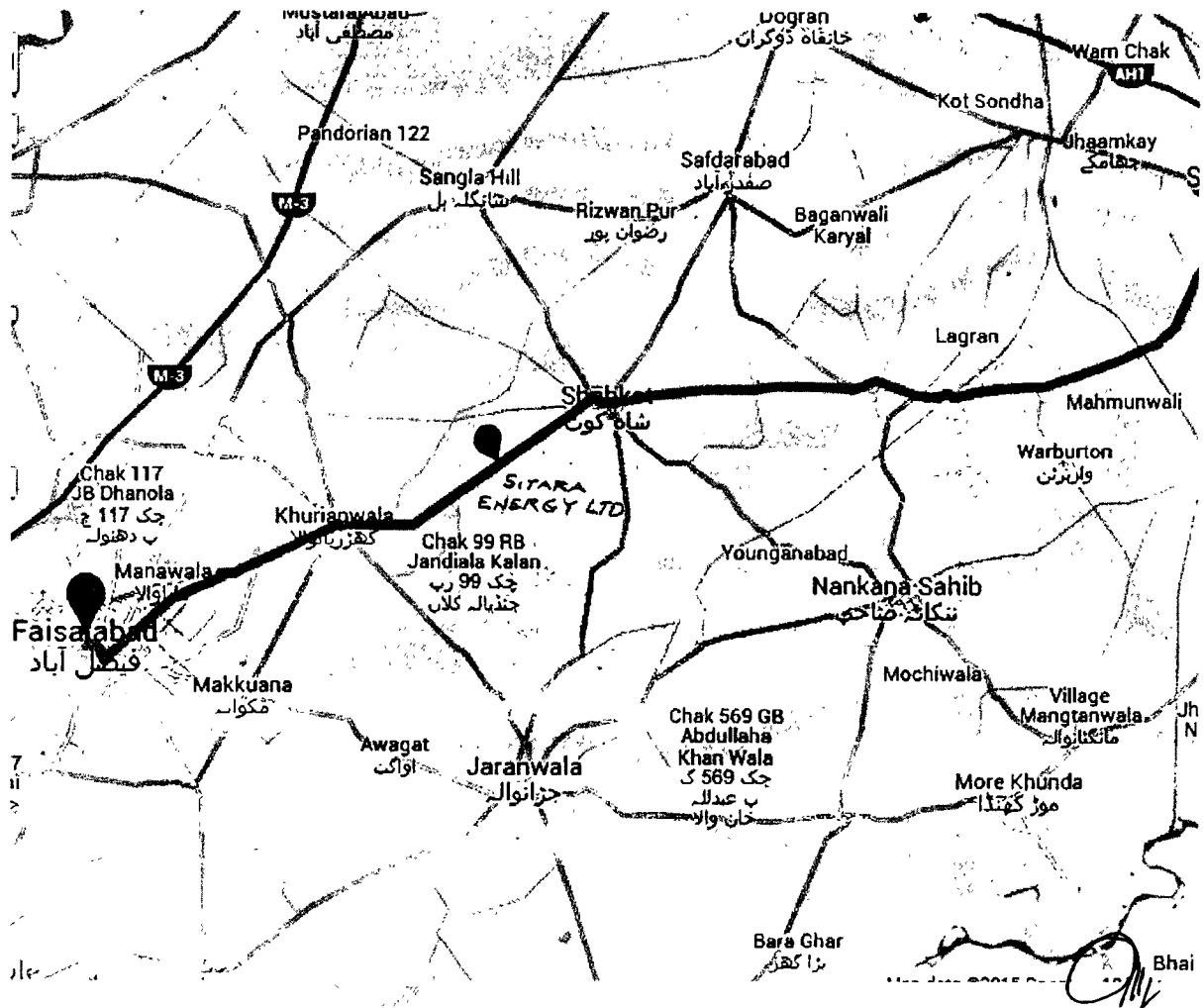
**Location of the Generation Facility/Power Plant of the Licensee/SEL**



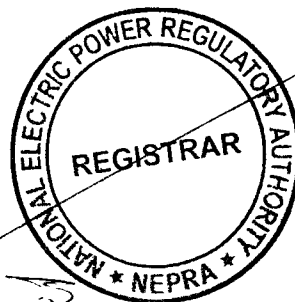
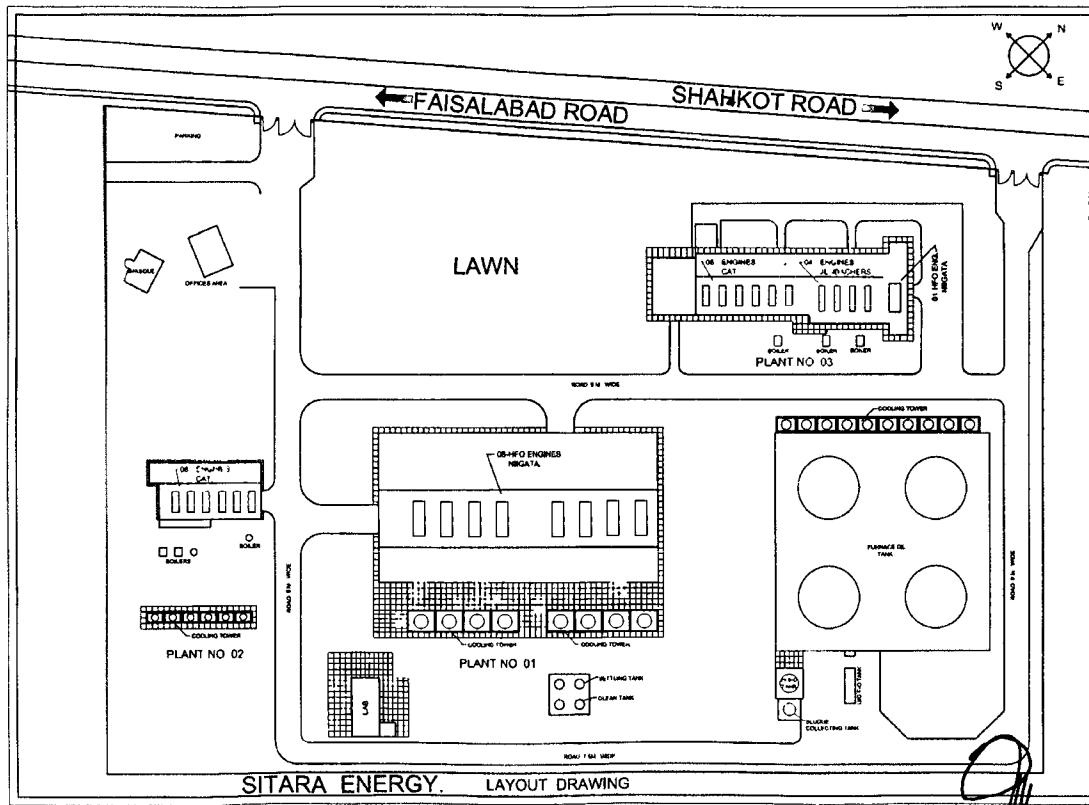
Location of the Generation Facility/Power Plant of the Licensee/SEL



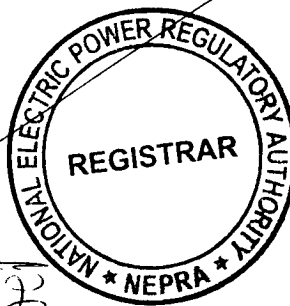
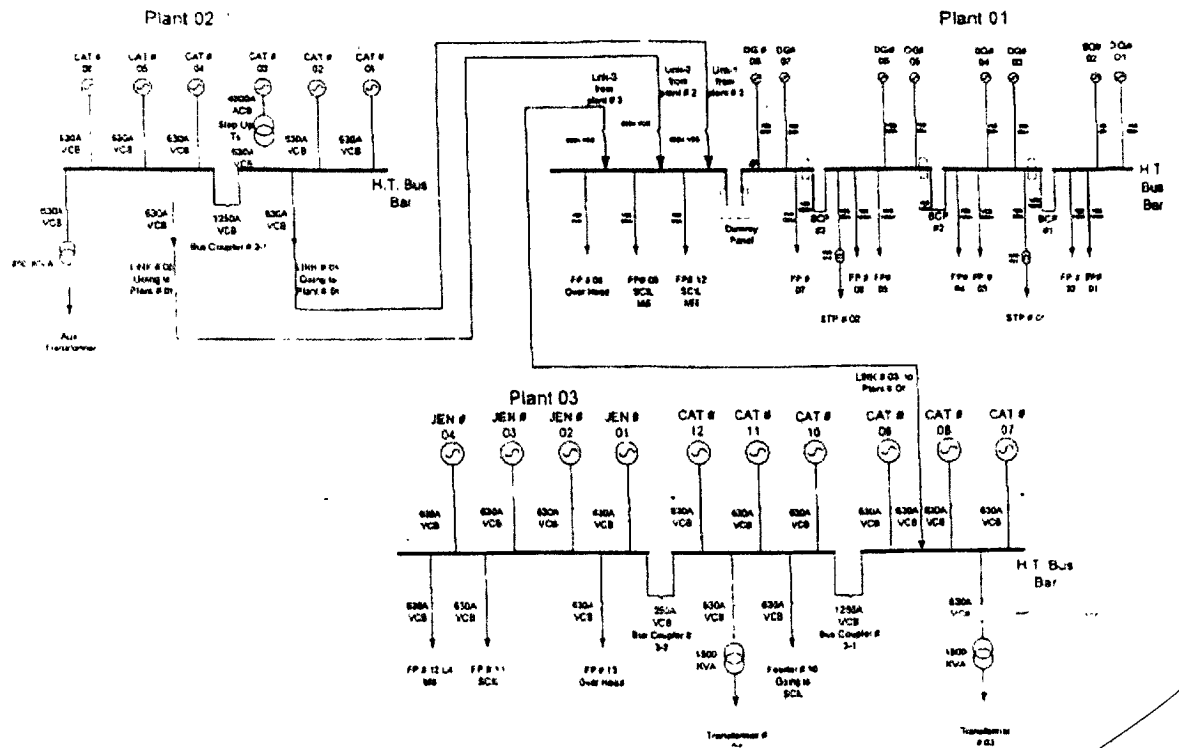

the Generation Facility/Power Plant of the Licensee/SEL**



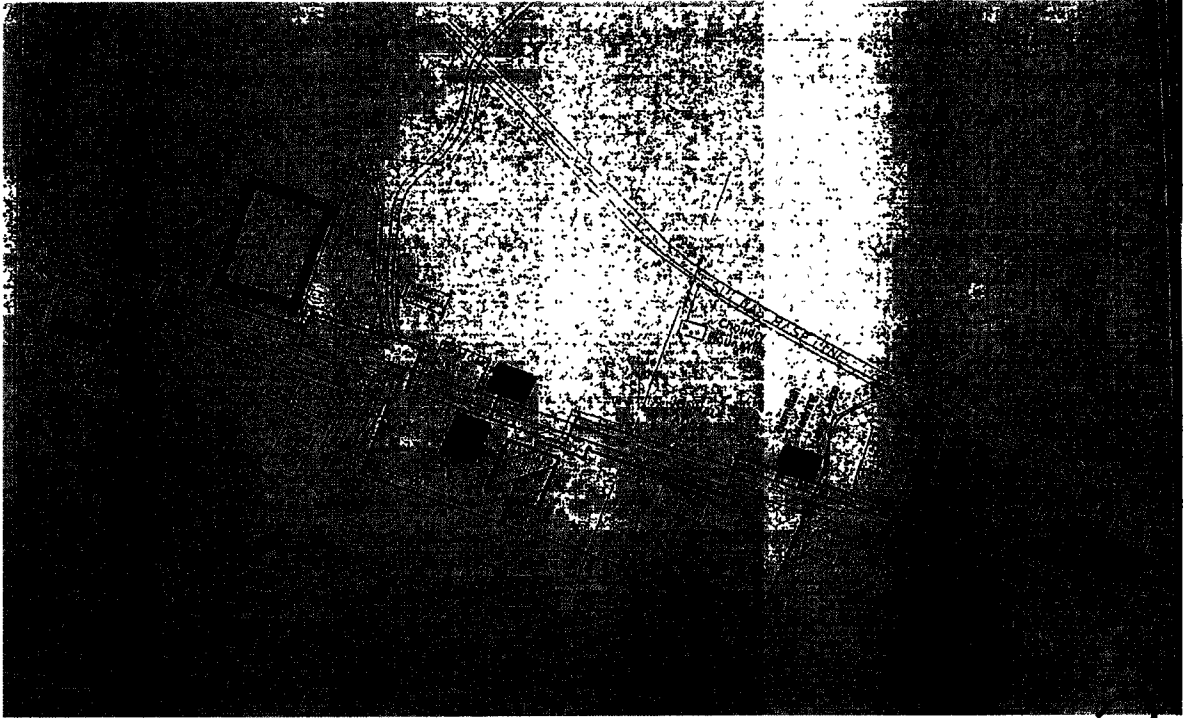

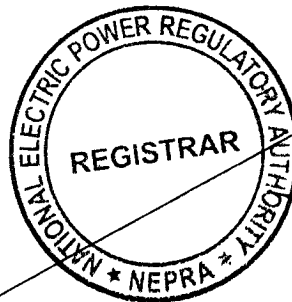
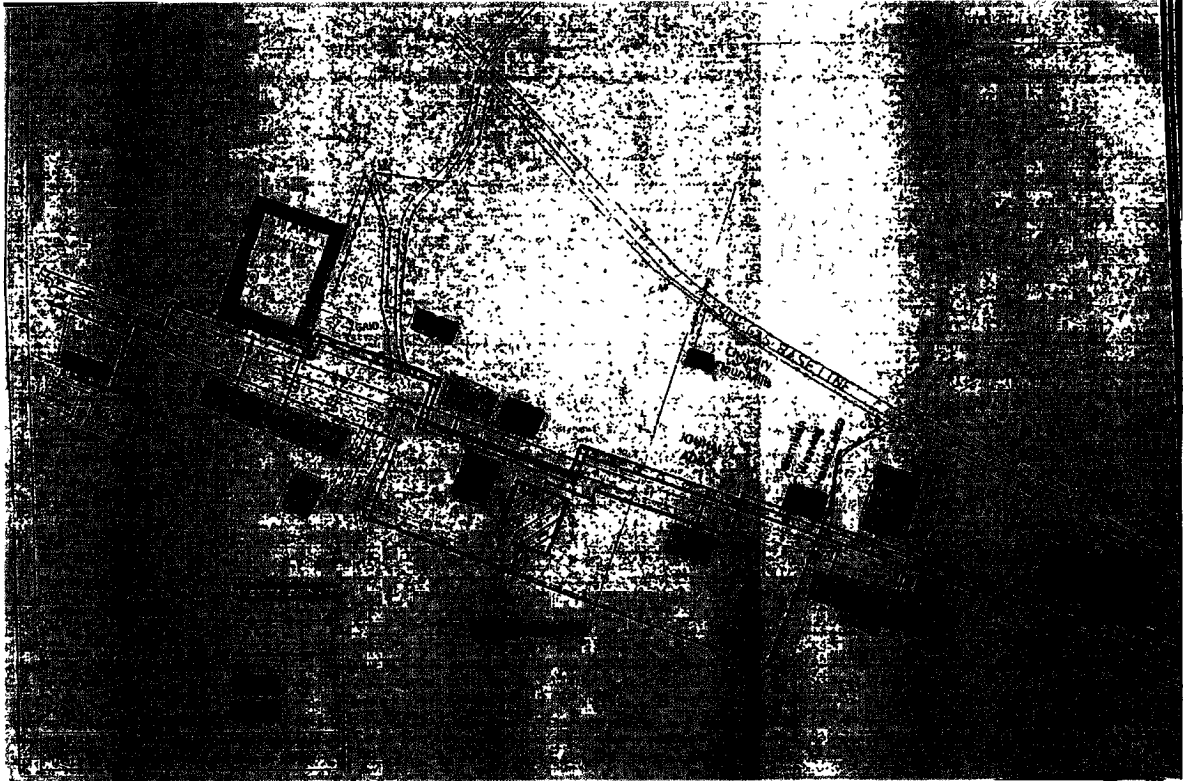
**Layout of the Distribution Network (i.e. Feeder No.6) of Generation  
Facility/Power Plant of the Licensee/SEL**



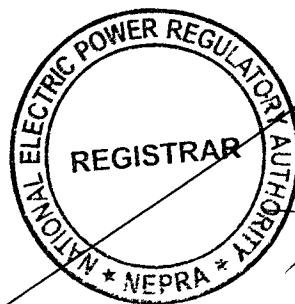
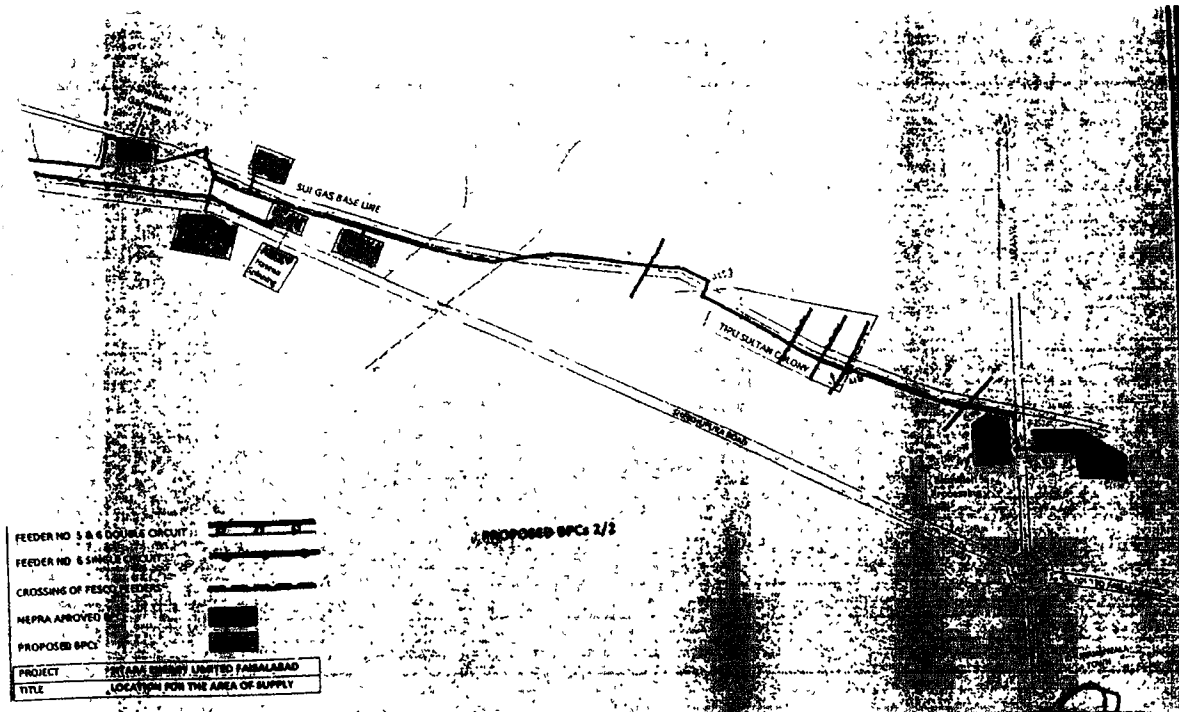

Facility/Power Plant of the Licensee/SEL**

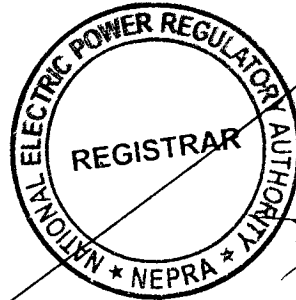


**Layout of the Distribution Network (Proposed BPCs) of Generation Facility/Power Plant of the Licensee/SEL**
