Order of the Authority for Allowing Provisional Extension of Certificate of Registration to CPPA-G as Power Purchaser/Special Purpose Agent of DISCO(s)

In terms of Rule-3 of the NEPRA (Market Operator Registration, Standards and Procedure) Rules, 2015, (the "Market Rules") the Authority granted a Certificate of Registration to CPPA-G to act as Market Operator (MO) and Power Purchaser/Special Purpose Agent of DISCO(s). Further, the Authority at the time of grant of the said Registration, had fixed the term of the same to five (05) years which expired on November 15, 2023.

- 2. Initially, CPPA-G was performing both the MO and Agency functions under the above Certificate of Registration. The MO functions of CPPA-G are now covered in the MO Licence dated May 31, 2022. Further, under Section 25A of the Regulation of the Generation, Transmission and Distribution of Electric Power Act, 1997 (the "NEPRA Act"), to perform the Agency functions, CPPA-G has also filed an application along with the draft Agency Code, for the grant of Registration to act as a Special Purpose Agent (SPA).
- 3. In this regard, a notice for seeking comments was published in the press on March 18, 2023. Further, notices were also sent to relevant stakeholders on March 21, 2023. In response to the notices, various stakeholders have submitted comments/observations on different clauses of the draft Agency Code. The Authority has observed that the draft Agency Code requires substantial changes/improvement and considers that the finalization of the same by CPPA-G and its subsequent approval by the Authority will take some time.
- 4. Foregoing in view, the Authority hereby decides to extend the term of existing Registration of CPPA-G (to the extent of Agency functions only), until the grant





of SPA Registration under section 25A of the NEPRA Act. All the terms and conditions of the Registration shall apply *mutatis mutandis* to the extent not inconsistent with the provisions of the NEPRA Act and other applicable documents. Further to the above, CPPA-G shall comply with all relevant determinations, and directions of the Authority as may be issued from time to time.
