<u>Determination of the Authority</u> <u>in the matter of Authority Proposed Modification (APM) in the Transmission Licence (TL) of National Transmission and Dispatch Company Limited (NTDC)</u>

April 07, 2014 Reference No. LAT-01

(A). Background

- (i). The Authority granted a Transmission Licence (No. TL/01/2002, dated December 31, 2002) to National Transmission and Dispatch Company Limited (NTDC) under Section 17 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 ("the NEPRA Act"). According to Article-7 of the above mentioned Licence, NTDC was allowed to purchase Electric Power to meet the demands of eight (08) Ex-WAPDA Distribution Companies (XWDISCOS).
- (ii). Later on, the Authority granted two more Distribution Licences to Sukkur Electric Power Company Limited-SEPCO (No. 21/DL/2011, dated August 18, 2011) and Tribal Area Electric Supply Company Limited-TESCO (No.22/DL/2013, dated August 12, 2013), increasing the total number of XWDISCOS from eight (8) to ten (10), requiring a modification in the above mentioned Transmission Licence of NTDC.

(B). Initiation & Processing of Modification

(i). In view of the above, the Authority in accordance with Section 26 of the NEPRA Act read with Regulation-10 of the NEPRA Licensing (Application and Modification Procedure) Regulations,1999 (the "Regulations") decided to modify the Article-7 of the Transmission Licence of NTDC through

an APM.

(ii). In terms of Regulation 10(1) of the Regulations, the APM was communicated to NTDC through this office letter dated August 28, 2013. Furthermore, pursuant to sub Regulation 4(b) of the Regulation-10 of the Regulations, a notice about the APM was also published in the newspapers of September 14, 2013, seeking comments of general public and other stake holders.

(C). Response of Stakeholders

- (i). In response to the above mentioned notice, NTDC through its Letter No. GM/WPPO/789-91, dated January 27, 2014 agreed to the communicated APM.
- (ii). Apart from the above, no comments from any of the stakeholder were received. In view of the said, the Authority considered it appropriate to proceed further in the matter for modification of Article-7(1) of Transmission Licence of NTDC.

(D). Approval of APM

- (i). The Authority considered the matter in its Regulatory Meeting held on February 19, 2014 and approved the communicated APM in the Transmission Licence of the NTDC thereby modifying the Article 7(1) of the Transmission Licence of NTDC.
- (ii). The modified Face Sheet indicating the required changes is attached as Annexure to this Determination of the Authority. The approval of the APM will be subject to the provisions contained in the NEPRA Act, relevant rules and regulations framed there under.




