(FESCO) Case No. NEPRA/TRF-40/FESCO-2005 - Intimation of Decision of Tariff pursuant to Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act (XI, of 1997)

<u>Decision of the Authority in the Matter of</u> <u>Monthly Adjustment of Power Purchase Price (PPP) for</u> <u>Faisalabad Electric Supply Company Limited (FESCO)</u>

The Authority considered FESCO's request for monthly adjustment of power purchase price (PPP) variation for the month of January 2009 pursuant to paragraph II of the order of the Authority dated 23rd August 2008 notified by the Federal Government vide SRO 960(I)/2008. According to the information/evidence placed before the Authority, the actual PPP for the month of January 2009, charged to FESCO by Central Power Purchasing Agency (CPPA), was Rs. 6.6195/kWh, which was Rs. 1.1699/kWh higher than the reference PPP of Rs.5.4496/kWh. After incorporating the impact of target distribution losses of 11.23%, the required upward per unit adjustment in the determined tariff has been assessed as Rs. 1.35 (Annex I). This adjustment shall apply to all consumer categories except life line residential consumers.

Faisalabad Electric Supply Company Limited Adjustment for Power Purchase Price For the Month of January 2009

$$\Delta PPP = \pm \frac{\left(PPP_{(Act)} - PPP_{(Ref)}\right)}{\left(1 - L\right)}$$

Where:

Δ**PPP** is the variation in Power Purchase Price including fuel price variation in terms of Rs./kWh purchased occurred in a month against the reference PPP.

PPP(Act) is the actual PPP (Rs. 6.6195/kWh purchased for January 2009) during the month for which the adjustment is required to be made.

PPP_(Ref) is the reference power purchase price (PPP) of Rs. 5.4496/kWh.

L is the target losses which are 11.23% for FY 2008-09.

Replacing values in the formula we get,

$$\Delta PPP = (6.6195-5.4496)/(1-11.23\%)$$

 $\Delta PPP = (+) Rs. 1.32/kWh$

According to the decision of the Authority, the impact of variation in the power purchase price shall not be passed on to the lifeline residential consumers. The ratio of lifeline consumers in FESCO's total sales is around 2.23%. The adjusted $\triangle PPP$ shall be calculated as under:

PPP = 1.32/(1-2.23%)
 Δ PPP = (+) Rs. 1.35/kWh

The impact of change in the power purchase will be calculated according to the following formula:

PPP Adjustment =
$$\pm \Delta PPP \times U(C)$$

Where:

U(C) are units consumed by the consumer during the month for which the adjustment is required to be made.
