**NOTIFICATION**

S.R.O. 362 (I)/2011.- In pursuance of sub-section (4) of section 31 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL of 1997), the Federal Government is pleased to direct that the following amendments shall be made in its Notification No. S.R.O. 235(I)/2011 dated, the 15<sup>th</sup> March, 2011, namely:-

In the aforesaid Notification,-

- (a) In the preamble, in the first proviso, for the figure "2", the figure "4" shall be substituted; and
- (b) for Schedule-II, the following shall be substituted, namely:-


