

**DECISION OF THE AUTHORITY REGARDING RECONSIDERATION REQUEST FILED  
MINISTRY OF WATER & POWER WITH RESPECT TO DECISION OF THE AUTHORITY DATED  
9<sup>TH</sup> JANUARY 2013**


Power Acquisition Requests (PARs) filed by Faisalabad Electric Supply Company (FESCO), Hyderabad Electric Supply Company (HESCO) and Sukkur Electric Power Company (SEPCO) for procurement of power from M/s Galaxy Textile Mills, Thatta Power (Pvt.) Ltd., Shikarpur Power (Pvt.) Ltd., Dadu Energy (Pvt.) Ltd., and Omini Power (Pvt.) Ltd were decided by the Authority vide decision dated 9<sup>th</sup> of January 2013 and the same was intimated to the Government of Pakistan for notification in the official gazette as per Section 31(4) of the NEPRA Act, 1997. Having considered the submissions of the Distribution Companies, comments of the stakeholders and keeping in view the benchmarks established by the Authority in the case of Independent Power Producers (IPPs), decision in the matter was issued on 9<sup>th</sup> January 2013. Vide letter dated 8<sup>th</sup> March 2013, Ministry of Water & Power, Government of Pakistan filed a request to reconsider the decision dated 9<sup>th</sup> January 2013 in respect of referred 5 companies generation with a request to approve the higher tariff as per proposal of PEPCO.


2. The above referred request was considered by the Authority and a hearing into the matter was also held on 20<sup>th</sup> of March 2013 which was attended by the representative of Ministry of Water & Power, Ministry of Finance, FESCO, SEPCO, HESCO, Central Power Purchasing Agency (CPPA) of NTDC and interveners, M/s IS.ZA.AD Associate.


3. During the pendency of the above mentioned reconsideration request of Government of Pakistan, Ministry of Water & Power vide letter dated 16<sup>th</sup> of September, 2013 has requested for withdrawal of its request dated 8<sup>th</sup> March, 2013.


