
The Authority while vetting the tariff determinations of Faisalabad Electric Supply Company Ltd. (FESCO) for the FY 2012-13, has noted a typo error.



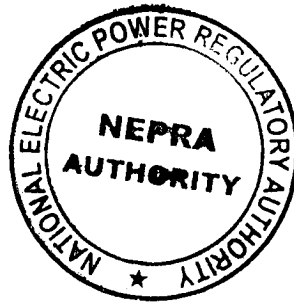


