

AUTHORITY DECISION DATED MARCH 10, 2015 PERTAINING TO THE FY 2014-15**






4. Considering the fact that the FESCO is no more interested in pursuing the motion for leave for review, the motion for leave for review is accordingly dismissed as withdrawn.






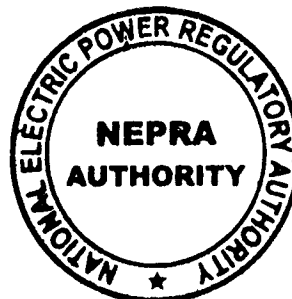
