NOTIFICATION

S.R.O.1179(I)/2008.- In pursuance of sub-section (4) of section 31 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL 1997), the Federal Government, is pleased to direct that the following amendment shall be made, and shall be deemed to have been so made, on the 05th September, 2008, in its Notification number S.R.O. 961(I)/2008 dated the 5th September 2008, namely:-

F - SEASONAL INDUSTRIAL SUPPLY TARIFF

Note:

125% of relevant industrial tariff

Tariff-F consumers will have the option to convert to Regular Tariff and vice versa. This option can be exercised at the time of a new connection or at the beginning of the season. Once exercised, the option remains in force for at least one year.


