(LESCO) [Case No. NEPRA/TRF-109/LESCO-2008 (3)] - Intimation of Decision of Tariff pursuant to Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act (XL of 1997)

Lahore Electric Supply Company Limited Adjustment for Power Purchase Price For the Month of October 2008

$$\Delta PPP = \pm \frac{\left(PPP_{(Act)} - PPP_{(Ref)}\right)}{\left(1 - L\right)}$$

Where:

PPP is the variation in Power Purchase Price including fuel price variation in terms of Rs./kWh against the reference PPP. purchased occurred in a month

PPP(Act) is the actual PPP (Rs. 6.7137/kWh purchased for October 2008) during the month for which the adjustment is required to be made.

PPP_(Ref) is the reference power purchase price (PPP) of Rs. 5.4000/kWh.

L is the target losses which are 12.30% for FY 2008-09.

Replacing values in the formula we get,

$$\Delta PPP = (6.7137-5.4000)/(1-12.30\%)$$

 $\Delta PPP = (+) \text{ Rs. } 1.50/\text{kWh}$

The impact of change in the power purchase price will be calculated according to the following formula:

PPP Adjustment =
$$\pm \Delta PPP \times U(C)$$

Where:

U(C) is units consumed by the consumer during the month for which the adjustment is required to be made





Decision of the Authority in the Matter of Monthly Adjustment of Power Purchase Price (PPP) for Lahore Electric Supply Company Limited (LESCO)

The Authority considered LESCO's request for monthly adjustment of power purchase price (PPP) variation pursuant to paragraph II of the order of the Authority dated 29th September 2008 notified by the Federal Government vide SRO 1180(I)/2008. According to the information/evidence placed before the Authority, the actual PPP for the month of October 2008, charged to LESCO by Central Power Purchasing Agency (CPPA), was Rs. 6.7137/kWh, which was Rs. 1.3137/kWh higher than the reference PPP of Rs.5.4000/kWh. After incorporating the impact of target distribution losses of 12.30%, the required upward per unit adjustment in the determined tariff has been assessed as Rs. 1.50 (Annex I).
