**NOTIFICATION**

S.R.O. 905 (I)/2010.- In pursuance of sub-section (4) of section 31 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL 1997), the Federal Government is pleased to direct that the following amendments shall be made in its Notification No. S.R.O.1125 (I)/2009, dated the 21<sup>st</sup> December 2009, namely:-

In the aforesaid Notification, for Schedule-II, the following shall be substituted, namely:-
