



DECISION OF THE AUTHORITY IN THE MATTER OF MOTION FOR LEAVE FOR REVIEW FILED BY QUETTA ELECTRIC SUPPLY COMPANY (QESCO) AGAINST DETERMINATION OF THE AUTHORITY FOR ITS SUPPLY OF POWER TARIFF FOR THE FY 2019-20

1. The Authority determined Supply of Power Tariff pertaining to the FY 2018-19 & FY 2019-20 for Quetta Electric Supply Company Limited (QESCO), hereinafter called "the Petitioner or QESCO", vide determination dated December 08, 2020. The Petitioner being aggrieved with the determination, filed a Motion for leave for Review dated January 12, 2021, against the said determination.
2. The Motion for Leave for Review (MLR) was admitted by the Authority. The Authority in order to meet the ends of natural justice and to arrive at an informed decision, decided to conduct a hearing in the matter. Initially hearing was scheduled on February 24, 2021, however the same was re-scheduled on March 02, 2021 upon request of the Petitioner at NEPRA Tower through ZOOM; notices of hearing were sent to parties to the proceedings.
3. The Authority, however, considering the fact that the determination against which the MLR has been filed by the Petitioner has already been notified by the Federal Government vide SRO dated February 12, 2021, which was made applicable with immediate effect, has decided to return back the subject Motion to the Petitioner, with the directions to submit the concerns raised in the MLR in its next tariff petition for consideration of the Authority. The Petitioner is directed to file its Multi Year Tariff Petition, as already directed, without further delay.
