





S.R.O. 1017 (I)/2013: - Pursuant to Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 as amended through Regulation of Generation, Transmission and Distribution of Electric Power (Amendment) Act 2011, the National Electric Power Regulatory Authority, in continuation of its earlier decision notified vide S.R.O. 614(I)/2013 dated June 26, 2013, makes and notifies the following further adjustment in the approved tariff on account of variation in fuel charge for the month of May 2013 in respect of Ex-WAPDA Distribution Companies (XWDISCOs):

Actual Fuel Charges Component for May 2013	Rs.7.4371/kWh
Corresponding Reference Fuel Charges Component (Determined for FY 2012-13)	Rs 8.3697/kWh
Fuel Charges Variation for the month of May 2013 (Decrease)	(Rs.0.9327/kWh)

2. The above adjustment a decrease of (Rs.0.9327/kWh) shall be applicable to all the consumer categories except lifeline consumers of all the XWDISCOs. The said adjustment shall be shown separately in the consumers' bills on the basis of units billed to the consumers in the month of May 2013 by the XWDISCOs. XWDISCOs shall pass on the benefit of decrease in fuel charges adjustment in respect of May 2013 in the billing month of May, 2014.

3. While affecting the Fuel Adjustment Charges, the concerned DISCOs shall keep in view and strictly comply with the orders of the courts notwithstanding this order.


