

S.R.O. 937(I)/2009: - In pursuance of the Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997 and subsequent amendment made in that sub-section through an Ordinance No. XVIII of 2009 dated July 31 2009, the National Electric Power Regulatory Authority is pleased to determine and notify the following adjustment in fuel cost component on account of fuel price variation for the month of August 2009 for Ex-WAPDA Distribution Companies:

Actual Fuel Cost Component for August 2009	Rs. 4.01/kWh
Reference Fuel Cost Component	Rs. 4.14/kWh
Fuel Price Variation (Δ PPP)	Rs. 0.13/kWh (-)

The above adjustment shall be applicable to all the consumer categories except lifeline and agriculture consumers of all Ex-WAPDA Distribution Companies. Ex-WAPDA Distribution Companies shall show the fuel price adjustment as determined by the Authority for the month of September separately in the consumers' bills and the billing impact shall be worked out on the basis of consumption by the consumer in the month of August 2009.



S.R.O. 938(I)/2009: - In pursuance of the Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997 and subsequent amendment made in that sub-section through an Ordinance No. XVIII of 2009 dated July 31 2009, the National Electric Power Regulatory Authority is pleased to determine and notify the following adjustment in fuel cost component on account of fuel price variation for the month of September 2009 for Ex-WAPDA Distribution Companies:

Actual Fuel Cost Component for September 2009	Rs. 4.34/kWh
Reference Fuel Cost Component	Rs. 4.14/kWh
Fuel Price Variation (Δ PPP)	Rs. 0.20/kWh (+)

The above adjustment shall be applicable to all the consumer categories except lifeline consumers of all Ex-WAPDA Distribution Companies. Ex-WAPDA Distribution Companies shall show the fuel price adjustment as determined by the Authority for the month of September separately in the consumers' bills and the billing impact shall be worked out on the basis of consumption by the consumer in the month of September 2009.
