Please find enclosed the decision along with schedule of tariff (02 pages) of the Authority in respect of adjustment on the Non-escalable Component of Capacity Part of the tariff relating to tax for Central Power Generation Company Ltd. (CPGCL) in Case No. NEPRA/TRF-44/CPGCL-2005.

- 2. Summary of decision is:
 - Adjustment on account of Non-escalable component of capacity part of the tariff relating to Tax and applicable for the month of July 2008 only.
- 3. The decision is being intimated to the Federal Government for the purpose of notification of adjustment in the approved tariff through the official Gazette pursuant to Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act (XL of 1997) and Rule 16(11) of the National Electric Power Regulatory Authority Tariff (Standards and Procedure) Rules, 1998.
- 4. In view of above, the tariff adjustments intimated vide letters No. NEPRA/TRF-44/CPGCL-2005/6510-12 dated 05.03.2008, No. 6555-57 dated 07.03.2008, No. 7734-36 dated 30.05.2008, No. 8585-87 dated 26.06.2008, No. 8598-8600 dated 27.06.2008 and No. 8816-18 dated 02.07.2008 need to be notified prior to the notification of the attached schedule in order to implement tariff adjustment in respect of CPGCL.

Decision of the Authority in the Matter of Adjustment of the Non-Escalable component of capacity Part of the Tariff Relating to Tax for CPGCL for the Month of July, 2008

Pursuant to the Authority's decision dated February 24, 2006 in respect of generation tariff for Central Power Generation Company Ltd. (CPGCL), the Non-Escalable part of Capacity Purchase Price has been adjusted for the month of July, 2008 to cater for the payment of advance tax paid to Federal Government by CPGCL for the 4th quarter of the FY07-08. This adjustment on account of tax payment shall only be applicable for the month of July, 2008 and all the remaining components of the Non-Escalable capacity charge will remain the same. The Non-Escalable part of Capacity Purchase Price of (CPGCL) tariff is accordingly been revised, as indicated hereunder:

The revised tariff shall become immediately applicable as mentioned in S.R.O 661(I)/2006 dated June 24, 2006, subject to any difference in the tariff notified by the Federal Government as per section 31 (4) of the National Electric Power Regulatory Authority Act, 1997. In case the notified rate is different from the one already allowed for the immediate application the requisite adjustment in tariff shall be made as soon as possible but not than the succeeding billing month.


