Please find enclosed the decision along with schedule of tariff (02 pages) of the Authority in respect of adjustment on the Non-escalable Component of Capacity Part of the tariff relating to tax for Central Power Generation Company Ltd. (CPGCL) in Case No. NEPRA/TRF-44/CPGCL-2005.

- 2. Summary of decision is:
  - Adjustment on account of Non-escalable part of the tariff relating to Tax and applicable for the month of February 2008 only.

The decision is being intimated to the Federal Government for the purpose of notification of adjustment in the approved tariff through the official Gazette pursuant to Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act (XL of 1997) and Rule 16(11) of the National Electric Power Regulatory Authority Tariff (Standards and Procedure) Rules, 1998.

## Decision of the Authority in the Matter of Adjustment of the Non-Escalable component of capacity Part of the Tariff Relating to Tax for CPGCL for the Month of February, 2008

Pursuant to the Authority's decision dated February 24, 2006 in respect of generation tariff for Central Power Generation Company Ltd. (CPGCL), the Non-Escalable part of Capacity Purchase Price has been adjusted for the month of February, 2008 to cater for the payment of advance tax paid to Federal Government by CPGCL. The Non-Escalable part of the tariff relating to Capacity Purchase Price has been revised for notification in the official Gazette as per the attached schedule. This adjustment shall only be applicable for the month of February, 2008 and all the remaining components of the Non- Escalable capacity charge will remain the same.

The Tariff will become immediately applicable as mentioned in S.R.O 661(I)/2006 dated June 21, 2006 published in The Gazette of Pakistan dated June 24, 2006.
