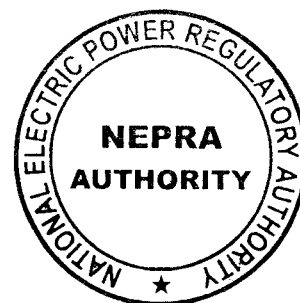


**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT OF THE ENERGY

Pursuant to the Authority's decision dated February 24, 2006 in respect of generation tariff for Central Power Generation Company Ltd. 



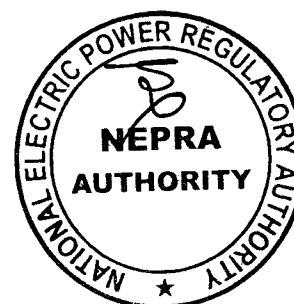
