


DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN THE ENERGY CHARGE PART OF THE TARIFF RELATING TO FUEL FOR CENTRAL POWER GENERATION COMPANY LIMITED (CPGCL) OF 747 MW COMBINED CYCLE POWER PROJECT (CCPP) AT GUDDU

Pursuant to Decision of the Authority dated April 26, 2016, read with corrigendum dated August 10, 2016 and notified vide SRO 830(1)/2016 in respect of generation tariff for Central Power Generation Company Ltd (CPGCL) for its Combined Cycle Power Project at Guddu, adjustment has been made in the fuel component of energy charge part, due to change in gas price w.e.f December 15, 2016.
