DECISION OF THE AUTHORITY IN THE MATTER OF INDEXATION/ ADJUSTMENT OF TARIFF FOR CENTRAL POWER GENERATION COMPANY LIMITED FOR 747 MW COMBINED CYCLE POWER PROJECT AT GUDDU.

1. Pursuant to the decision of the Authority dated April 7, 2017 notified vide S.R.O No. 448(I)/2017 dated May 30, 2017 in the matter of Motion for Leave for Review, the relevant tariff components of Central Power Generation Company Limited for 747 MW Power Plant located at Guddu (CPGCL-Guddu) in respect of the period April-June 2019 quarter has been revised on account of US CPI, CPI (General) Local and exchange rate variation in accordance with the requisite indexation/adjustment mechanism stipulated in the decision of the Authority. The revised tariff indicated hereunder shall be immediately applicable:

- 2. According to the documentary evidence provided by CPGCL-Guddu vide letter dated May 2, 2019, the HSD inventory is 15,235 liters only as of March 2019. However, in the instant case, the Authority allowed cost of working capital for HSD fuel inventory for 7 days at 60% load which was assessed to be 14.466 million liters. Since CPGCL-Guddu has not maintained the required inventory, the Authority has decided to disallow the cost of working capital component till the time GPGCL-Guddu maintains the required fuel inventory and submits the documentary evidence of the same.
- 3. The above referred revised tariff components attached as Annex-I are to be notified in the official gazette, in accordance with the provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.
