DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN THE ENERGY CHARGE PART OF THE TARIFF RELATING TO GAS W.E.F. 1ST JANUARY 2023 FOR CENTRAL POWER GENERATION COMPANY LIMITED.

- 1. Pursuant to the Authority's decision dated February 24, 2006 in respect of generation tariff for Central Power Generation Company Ltd (CPGCL), the fuel portion of energy charge part of tariff of CPGCL is required to be adjusted for variation in gas price(s).
- 2. The fuel cost components have been revised on the basis of notified gas price of Rs. 1,050/MMBTU by Oil and Gas Regulatory Authority (OGRA) dated February 15, 2023. The block-wise revised FCCs of energy charge part of CPGCL's tariff are indicated hereunder and shall be immediately applicable on units delivered basis:
