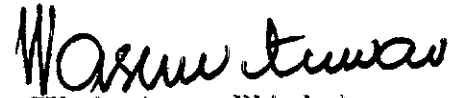
Subject: Decision of the Authority in the matter of Adjustment/Indexation in Insurance Component of Capacity Charge Part of tariff for the Period of August 04, 2024 to July 29, 2025 for Central Power Generation Company Limited for its 747 MW Combined Cycle Power Project at Guddu

Dear Sir,

Please find enclosed herewith the subject Decision of the Authority along with Annex-I (total 02 pages) regarding adjustment in Insurance Component of Capacity Charge Part of tariff on account of Actual Insurance Premium for the period August 04, 2024 to July 29, 2025 in respect of Central Power Generation Company Limited for 747 MW Combined Cycle Power Project at Guddu in Case No. NEPRA/TRF-322/CPGCL-2015.

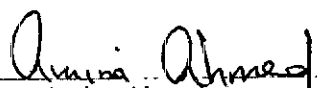

DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT/INDEXATION IN INSURANCE COMPONENT OF CAPACITY CHARGE PART OF TARIFF FOR THE PERIOD OF AUGUST 4, 2024 TO JULY 29, 2025 FOR CENTRAL POWER GENERATION COMPANY LIMITED FOR ITS 747 MW COMBINED CYCLE POWER PROJECT AT GUDDU

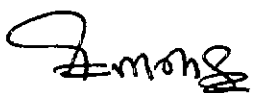
1. Pursuant to the decision of the Authority dated April 7, 2017 notified vide S.R.O. No. 448(I)/2017 on May 30, 2017 in the matter of Motion for Leave for Review (MLR) and decision of the Authority dated April 22, 2026 in the matter of MLR against the Authority's decision dated July 2, 2025 regarding tariff modification petition, the insurance component of capacity charge part of tariff of Central Power Generation Company Limited- 747 MW Combined Cycle Power Project at Guddu (CPGCL-Guddu) is subject to adjustment as per actual. CPGCL-Guddu requested to approve insurance component of Rs. 0.1184/kWh on the basis of insurance premium of Rs. 737,504,262/- (inclusive of sales tax) for the period of August 4, 2024 to July 29, 2025. CPGCL-Guddu in support of its request provided copies of premium invoices and payment evidences.
2. CPGCL-Guddu has included sales tax of Rs. 95,366,930/- in its requested insurance cost which is not in line with the decisions of the Authority in other similar cases and the same has not been considered. CPGCL may seek adjustment of this sales tax against its output tax. In case of non-adjustable sales tax, the same may be claimed as pass-through from the power purchaser under relevant section of the Power Purchase Agreement (PPA).
3. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under, which will be hereafter called as decision of the Authority in the matter:

"Based on the information and documentary evidences provided by CPGCL-Guddu, the insurance component of capacity charge part of tariff of Rs. 0.1031/kW/hour has been revised on basis of net insurance cost of Rs. 642,137,331/- (exclusive sales tax) for the coverage period of August 4, 2024 to July 29, 2025."
4. The revised tariff schedule attached as Annex-I shall be notified in the official Gazette in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL of 1997).
5. CPPA (G) to ensure that all payments are consistent with the tariff determination(s).

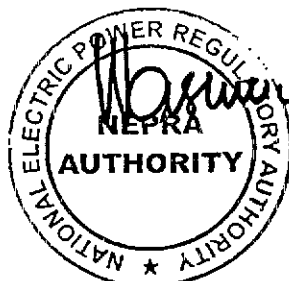
