2. Summary of Decision is:

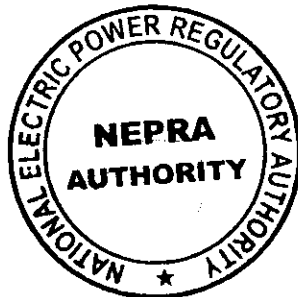
- Adjustment on account of fuel price variation for furnace oil on December 15, 2007.



Energy Charge Part of the Tariff Relating to Fuel for JPCL**






