DECISION OF THE AUTHORITY RELATING TO THE TARIFF ADJUSTMENT OF JAMSHORO POWER COMPANY LIMITED (JPCL) FOR VARIATION IN CPI ON JANUARY 01, 2008

Pursuant to NEPRA's determination in Case No. NEPRA/TRF-56/JPCL-2006, the tariff of Jamshoro Power Company Limited (JPCL) is subject to adjustment in Escalable Component of Capacity Purchase Price and Variable O&M part of Energy Purchase Price to compensate for variation in the Consumer Price Index (CPI). The tariff has therefore been accordingly revised w.e.f. January 01, 2008. The details of Capacity Charge and Variable O&M revised after adjustments are attached herewith for notification in the official gazette.


