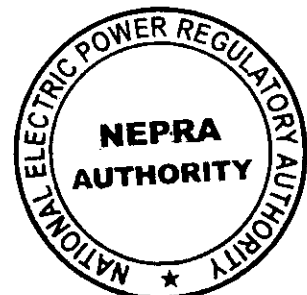


**Decision of the Authority in the Matter of Adjustment of the
