- 2. Summary of decision is:
 - Adjustment on account of Non-escalable part of the tariff relating to Tax and applicable for the month of February 2008 only.
- 3. The decision is being intimated to the Federal Government for the purpose of notification of adjustment in the approved tariff through the official Gazette pursuant to Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act (XL of 1997) and Rule 16(11) of the National Electric Power Regulatory Authority Tariff (Standards and Procedure) Rules, 1998.

In view of above, the tariff adjustments intimated vide letters No. NEPRA/TRF-56/JPCL-2006/4355-58 dated 18.10.2008, No. 4443-46 dated 29.10.2007, No. 4671-74 dated 08.11.2007, No. 5006-9 dated 26.11.2008, No. 5273-76 dated 12.12.2007, No.5416-19 dated 03.01.2008, No. 5422-25 dated 03.01.2008, No. 5816-18 dated 25.01.2008, No. 5820-22 dated 25.01.2008 and No. 6055-58 dated 04.02.2008 need to be notified prior to the notification of the attached schedule in order to implement tariff adjustments in respect of JPCL.

Decision of the Authority in the Matter of Adjustment of the Non-Escalable component of capacity Part of the Tariff Relating to Tax for JPCL

Pursuant to the Authority's decision dated July 02, 2007 in respect of generation tariff for Jamshoro Power Company Ltd. (JPCL), the Non-Escalable part of Capacity Purchase Price has been adjusted for the month of February, 2008 to cater for the payment of advance tax paid to Federal Government by JPCL. The Non-Escalable part of the tariff relating to Capacity Purchase Price has been revised for notification in the official Gazette as per the attached schedule. This adjustment shall only be applicable for the month of February, 2008 and all the remaining components of the Non-Escalable capacity charge will remain the same.

The Tariff will become immediately applicable as mentioned in S.R.O 1078(I)/2007 dated October 29, 2007, published in The Gazette of Pakistan dated November 21, 2007.
