
2. Summary of decision is:

- Adjustment on account of fuel price variation for gas on January 1, 2008.

3. The decision is being intimated to the Federal Government for the purpose of notification of adjustment in the approved tariff through the official Gazette pursuant to Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act (XL of 1997) and Rule 16(11) of the National Electric Power Regulatory Authority Tariff (Standards and Procedure) Rules, 1998.

In view of above, the tariff adjustments intimated vide letters No. NEPRA/TRF-56/JPCL-2006/4355-58 dated 18.10.2007, No. 5006-9 dated 26.11.2007, No. 5273-76 dated 12.12.2007, No. 5416-19 dated 03.01.2008, No. 5422-25 dated 03.01.2008, No. 5816-18 dated 25.01.2008, No. 5820-22 dated 25.01.2008, No. 6055-58 dated 04.02.2008, No. 6175-78 dated 13.02.2008 and No. 6205-8 dated 14.02.2008 need to be notified prior to the notification of the attached schedule in order to implement tariff adjustments in respect of JPCL.


Decision of the Authority in the Matter of Adjustment of the Energy Charge Part of the Tariff Relating to Fuel for JPCL




