
2. Summary of decision is:

- Adjustment on account of fuel price variation for furnace oil on January 31, 2008.

The decision is being intimated to the Federal Government for the purpose of notification of adjustment in the approved tariff through the official Gazette pursuant to Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act (XL of 1997) and Rule 16(11) of the National Electric Power Regulatory Authority Tariff (Standards and Procedure) Rules, 1998.

In view of above, the tariff adjustments intimated vide letters No. NEPRA/TRF-56/JPCL-2006/4355-58 dated 18.10.2008, No. 4443-46 dated 29.10.2007, No. 4671-74 dated 08.11.2007, No. 5006-9 dated 26.11.2008, No. 5273-76 dated 12.12.2007, No. 5403-6 dated 01.01.2008, No. 5416-19 dated 03.01.2008 and No. 5422-25 dated 03.01.2008 need to be notified prior to the notification of the attached schedule in order to implement tariff adjustments in respect of NPGCL.


**Decision of the Authority in the Matter of Adjustment of the




