- Adjustment on account of fuel price variation for furnace oil on April 15, 2009.



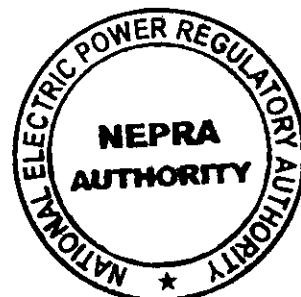

**Decision of the Authority in the Matter of Adjustment of the  
Energy Charge Part of the Tariff Relating to Fuel for  
Jamshoro Power Company Ltd.**


Pursuant to paragraph 18 of the Authority's decision dated July 02, 2007 in respect of generation tariff for Jamshoro Power Company Ltd. (JPCL), adjustments have been made in the fuel part of energy charge subsequent to change in furnace oil prices with effect from April 15, 2009. The block-wise revised fuel cost component for JPCL is indicated hereunder:




The revised tariff shall become immediately applicable as mentioned in S.R.O 1078(I)/2007 dated October 29, 2007, subject to any difference in the tariff notified by the Federal Government as per section 31 (4) of the National Electric Power Regulatory Authority Act, 1997. In case the notified rate is different from the one already allowed for the immediate application the requisite adjustment in tariff shall be made as soon as possible but not later than the succeeding billing month.



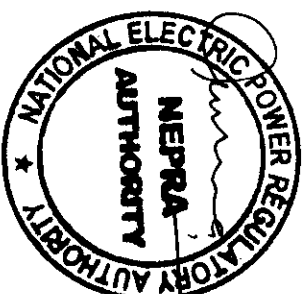
