Please find enclosed the decision along with schedules of tariff (03 pages) of the Authority in respect of adjustment in energy charge part of tariff on account of fuel price variation for Jamshoro Power Company Ltd. (JPCL) in Case No. NEPRA/TRF-56/JPCL-2006.

2. Summary of decision is:

- Adjustment on account of fuel price variation for furnace oil on January 31, 2009.
- Adjustment on account of fuel price variation for gas on January 01, 2009.



The decision is being intimated to the Federal Government for the purpose of notification of adjustment in the approved tariff through the official Gazette pursuant to Section 31 (4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act (XL of 1997) and Rule 16(11) of the National Electric Power Regulatory Authority Tariff (Standards and Procedure) Rules, 1998.

In view of above, the tariff adjustments intimated vide letters No. NEPRA/TRF-56/JPCL-2006/5422-25 dated 03.01.2008, No. 6175-78 dated 13.02.2008, No. 9404-7 dated 05.08.2008, No. 286-88 dated 29.09.2008, No. 538-41 dated 20.10.2008, No. 628-31 dated 30.10.2008, No. 717-20 dated 06.11.2008 and No. 877-80 dated 13.11.2008, 1310-13 dated 04.12.2008, No. 1615-18 dated 24.12.2008, No. 01-04 dated 01.01.2009, No. 07-10 dated 01.01.2009 and No. 378-381 dated 22.01.2009 need to be notified prior to the notification of the attached schedules in order to implement tariff adjustments in respect of JPCL.

Decision of the Authority in the Matter of Adjustment of the Energy Charge Part of the Tariff Relating To Fuel For Jamshoro Power Company Ltd.

Pursuant to paragraph 18 of the Authority's decision dated July 02, 2007 in respect of generation tariff for Jamshoro Power Company Ltd. 


The revised tariff shall become immediately applicable as mentioned in S.R.O 1078(I)/2007 dated October 29, 2007, subject to any difference in the tariff notified by the Federal Government as per section 31 (4) of the National Electric Power Regulatory Authority Act, 1997. In case the notified rate is different from the one already allowed for the immediate application the requisite adjustment in tariff shall be made as soon as possible but not later than the succeeding billing month.


