

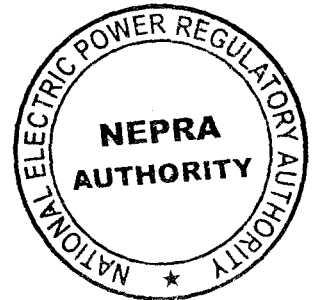

**DECISION OF THE AUTHORITY WITH RESPECT TO ENERGY CHARGE PART OF TARIFF
RELATING TO FUEL OF JAMSHORO POWER COMPANY LIMITED ON ACCOUNT OF FUEL
PRICE VARIATION (CASE NO. NEPRA/ TRF-56/JPCL-2006)**


Jamshoro Power Company Ltd. requested the Authority for adjustment of the fuel cost component based on fuel price variation for 2nd fortnight of April 2011. JPCL in support thereof provided copies of the quotations of Pakistan State Oil (PSO) and Purchase Order. Accordingly JPCL was allowed adjustment on the basis of fuel price of Rs. 60,844/-M.Ton. Decision in the matter was issued on 28th April 2011.


JPCL vide letter No. letter No. FD/JPCL/CF-I/1/7246 dated 4th June 2011 intimated that subsequent to the Authority's decision Pakistan State Oil (PSO) supplied 2,377.624 M.Ton fuel from Kemari @ Rs. 61,737/- M.Ton instead of offered rate of Rs. 60,844/-M.Ton from ZOT due to product constraints and tank-lorry strike during the later part of the fortnight. As a result of this change in arrangement of supply JPCL is required to pay additional cost of Rs. 2,123,218.232 on this account. In support of its claim JPCL provided copies of the sales invoices raised by PSO indicating the actual fuel supply from Ex-ZOT and Kemari.


Having examined the documentary evidence, the Authority considers that JPCL's claim of additional cost of Rs. 2,123,218.232 is legitimate therefore is allowed. However at this belated stage when JPCL has already raised the energy invoices to Central Power Purchasing Agency (CPPA) on the basis of the Authority's decision 28th April 2011. The earlier decision with respect to adjustment of fuel cost component cannot be revised. In view thereof, the Authority has decided to allow JPCL differential amount of Rs. 2,123,218.232 in the next monthly energy invoice as arrears.


