

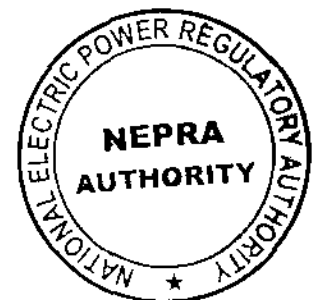

PART OF THE TARIFF RELATING TO FUEL FOR JAMSHORO POWER COMPANY LTD.**


