## DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT OF THE ENERGY CHARGE PART OF THE TARIFF RELATING TO FUEL FOR JAMSHORO POWER COMPANY LTD. (JPCL)

In accordance with the Authority's determination dated 3-7-2007 in case No. NEPRA/TRF-56/JPCL-2006, Jamshoro Power Company Ltd. (JPCL) vide letter No. FD/JPCL/CF-I/1/2559 dated 2nd January 2012 requested for adjustment in energy charge part of tariff on account of revised gas price notified by Oil and Gas Regulatory Authority (OGRA). Accordingly fuel cot component of JPCL was revised and decision in the matter was issued on 23-1-2012. Subsequently JPCL vide letter dated 30-1-2012 stated that in its previous request Gas Infrastructure Development Cess of Rs.27/MMBTU was not included. JPCL requested the Authority to review its decision dated 23-1-2012 and allow adjustment on the basis of gas price of Rs. 507.86/MMBTU which includes the Gas Infrastructure Development Cess of Rs. 27/MMBTU.

Fuel being pass through item is adjusted on account of fuel price variation. In this regard fuel cost component of NPGCL and IPPs was adjusted based on the revised gas price which also includes the Gas Infrastructure Development Cess. Considering the evidence provided by JPCL vide its abovereferred communication, the Authority has decided to modify its earlier decision dated 23-1-2012 and JPCL's fuel cost component is accordingly being revised based on the gas price of Rs. 507.86/MMBTU. The block-wise revised fuel cost component for JPCL w.e.f 1-1-2012 is indicated hereunder:
