

PART OF THE TARIFF RELATING TO FUEL FOR JAMSHORO POWER COMPANY LIMITED**


Pursuant to the Authority's decision dated September 01, 2015 notified vide S.R.O 1142(I)/2014 dated November 17, 2015 in respect of generation tariff for Jamshoro Power Company Ltd.
