## DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT OF THE NON-ESCALABLE COMPONENT OF CAPACITY PART OF THE TARIFF RELATING TO TAX FOR JPCL, VALID FOR THE MONTH OF JUNE 2015

Pursuant to the Authority's decision dated September 12, 2014 notified vide S.R.O 1097(I)/2014 dated December 01, 2014 and subsequent corrigendum issued vide decision No. NEPRA/TRF-255/JPCL-2014/ 5490-94 dated April 13, 2015 in respect of generation tariff for Jamshoro Power Company Ltd. (hereinafter "JPCL"), the Non-Escalable part of Capacity Purchase Price has been adjusted on account of advance tax of Rs. 159,317,000/-, Rs. 72,007,000/ and Rs. 62,994,000/- paid by JPCL to the Federal Government for 1st, 2nd and 3rd quarter of the FY 2014-15 under Payment Section 147 of the Income Tax Ordinance - 2001. This adjustment shall only be applicable for the month of June 2015. The Non-Escalable part of Capacity Purchase Price of JPCL tariff is accordingly been revised, as indicated hereunder and shall be immediately applicable.
