DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT OF THE NON-ESCALABLE COMPONENT OF CAPACITY PART OF THE TARIFF RELATING TO TAX FOR JPCL, VALID FOR THE MONTH OF SEPTEMBER 2016

Pursuant to the Authority's decision dated September 01, 2015 notified vide S.R.O. 1142(I)/2015 dated November 17, 2015 in respect of generation tariff for Jamshoro Power Company Ltd. (hereinafter "JPCL"), the Non-Escalable part of Capacity Purchase Price has been adjusted on account of advance tax of Rs. 100,583,000/- paid by JPCL to the Federal Government for 1st quarter of the FY 2016-17 under Payment Section 147 of the Income Tax Ordinance - 2001. This adjustment shall only be applicable for the month of September 2016. The Non-Escalable part of Capacity Purchase Price of JPCL tariff has accordingly been revised, as indicated hereunder and shall be immediately applicable.
