DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN THE ENERGY CHARGE PART OF THE TARIFF RELATING TO FUEL FOR JAMSHORO POWER COMPANY LIMITED

Pursuant to the Authority's decision dated September 01, 2015 notified vide S.R.O 1142(I)/2015 dated November 17, 2015 in respect of generation tariff for Jamshoro Power Company Limited, (hereinafter "JPCL"), adjustments have been made in the fuel cost component of energy charge part of JPCL, due to change in fuel prices for the 1st and 2nd fortnights for the month of September, 2016.
