DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT OF THE NON-ESCALABLE COMPONENT OF CAPACITY PART OF THE TARIFF RELATING TO TAX FOR **IPCL, VALID FOR THE MONTH OF MARCH 2016**

Pursuant to the Authority's decision dated September 01, 2015 notified vide S.R.O. 1142(I)/2015 dated November 17, 2015 in respect of generation tariff for Jamshoro Power Company Ltd. (hereinafter "JPCL"), the Non-Escalable part of Capacity Purchase Price has been adjusted on account of advance tax of Rs. 96,665,000/- paid by JPCL to the Federal Government for 3rd quarter of the FY 2015-16 under Payment Section 147 of the Income Tax Ordinance - 2001. This adjustment shall only be applicable for the month of March 2016. The Non-Escalable part of Capacity Purchase Price of JPCL tariff has accordingly been revised, as indicated hereunder and shall be immediately applicable.
