## DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT OF THE NON-ESCALABLE COMPONENT OF CAPACITY PART OF THE TARIFF RELATING TO TAX FOR IPCL, VALID FOR THE MONTH OF DECEMBER 2015

Pursuant to the Authority's decision dated September 01, 2015 notified vide S.R.O 1142(I)/2015 dated November 17, 2015 in respect of generation tariff for Jamshoro Power Company Ltd. (hereinafter "JPCL"), the Non-Escalable part of Capacity Purchase Price has been adjusted on account of advance tax of Rs. 95,664,000/- paid by JPCL to the Federal Government for 2<sup>nd</sup> quarter of the FY 2015-16 under Payment Section 147 of the Income Tax Ordinance – 2001. This adjustment shall only be applicable for the month of December 2015. The Non-Escalable part of Capacity Purchase Price of JPCL tariff is accordingly been revised, as indicated hereunder and shall be immediately applicable.
