DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT OF THE NON-ESCALABLE COMPONENT OF CAPACITY PART OF THE TARIFF RELATING TO TAX FOR **IPCL, VALID FOR THE MONTH OF SEPTEMBER 2015**

Pursuant to the Authority's decision dated September 12, 2014 notified vide S.R.O 1097(I)/2014 dated December 01, 2014 and subsequent corrigendum issued vide decision No. NEPRA/TRF-255/JPCL-2014/ 5490-94 dated April 13, 2015 in respect of generation tariff for Jamshoro Power Company Ltd. (hereinafter "JPCL"), the Non-Escalable part of Capacity Purchase Price has been adjusted on account of advance tax of Rs. 87,747,000/- paid by JPCL to the Federal Government for 1st quarter of the FY 2015-16 under Payment Section 147 of the Income Tax Ordinance - 2001. This adjustment shall only be applicable for the month of September 2015. The Non-Escalable part of Capacity Purchase Price of JPCL tariff is accordingly been revised, as indicated hereunder and shall be immediately applicable.
