

**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN THE ENERGY CHARGE  
PART OF THE TARIFF RELATING TO FUEL FOR JAMSHORO POWER COMPANY LTD. (JPCL)**


Pursuant to Decision of the Authority (Case No. NEPRA/TRF-255/JPCL-2014) dated September 1, 2015 in the matter of Motion for Leave for Review against the determination of the Authority dated September 12, 2014 and subsequent Corrigendum issued vide decision dated April 13, 2015, in respect of generation tariff for Jamshoro Power Company Ltd. (hereinafter "JPCL"), adjustments have been made in the fuel component of energy charge part of JPCL, due to change in gas prices w.e.f 15 December, 2016.
