


## DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT OF CALORIFIC VALUE FOR JAMSHORO POWER COMPANY LIMITED.

- 1. Pursuant to the Decision of the Authority dated 1<sup>st</sup> September, 2015, notified vide S.R.O. 1142(1)/2015 dated November 17, 2015, the Jamshoro Power Company Limited (JPCL) is required to maintain and submit a record of Calorific Value (CV) of furnace oil for adjustment of CV with respect to reference CV of 18,364 Btu/lb, duly supported with the copies of test reports.
- 2. Accordingly, JPCL submitted CV of furnace oil test reports certified by the fuel supplier i.e. PSO for the period covering 1st October 2017 to 31st December 2017 along with calculation. JPCL has claimed **Rs. 24,138,453**/receivable from the power purchaser on account of adjustment of actual CV.
- 3. The information was analyzed in the light of the evidence provided by JPCL and unit wise amount is calculated as:

- 4. The Authority has decided to approve **Rs. 24,138,453**/- receivable by JPCL on account of adjustment of actual CV against the reference CV of 18,364 Btu/lb for the period 1<sup>st</sup> October 2017 to 31<sup>st</sup> December 2017. The detailed calculations are attached as **Annex-I**.
- 5. The Central Power Purchasing Agency (Guarantee) Limited is directed to pay **Rs. 24,138,453**/- to JPCL on account of adjustment of CV for the period 1st October 2017 to 31st December 2017.





6. The above order of the Authority along with Annex-I shall be notified in the official gazette in accordance with the provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
