**DECISION OF THE AUTHORITY IN THE MATTER OF IMMEDIATE APPLICATION OF  
RLNG AS ALTERNATIVE FUEL FOR JAMSHORO POWER COMPANY LIMITED**

1. Jamshoro Power Company Limited (hereinafter referred as "JPCL") vide letter dated March 8, 2018, filed request for change in fuel price adjustment mechanism in order to utilize RLNG due to shortage of gas and cut in supply of furnace oil. JPCL also requested immediate application of RLNG as alternative fuel in accordance with Clause 4(7) of NEPRA (Tariff Standards and Procedure) Rules, 1998. JPCL vide letter dated 9<sup>th</sup> April 2018, further requested the Authority to expedite the matter for immediate application of RLNG as alternative fuel in view of the non-availability of gas and furnace oil, upcoming summer season and increase in demand of electricity.
2. The Authority has accepted the application of JPCL and decided to initiate proceedings to modify the existing mechanism of fuel cost component on account of RLNG. The hearing in the matter has been scheduled on 17<sup>th</sup> April 2018 at NEPRA Tower, Islamabad. Notice of hearing in the matter has appeared in newspapers on 10<sup>th</sup> of April 2018 inviting interventions/comments from stakeholders. Individual letters were also sent to stakeholders on 10<sup>th</sup> April 2018.
3. The Authority has considered the request of JPCL for immediate application of RLNG as alternative fuel in accordance with Rule 4(7) of NEPRA (Tariff Standards and Procedure) Rules, 1998. In a similar case of IPPs, the Authority vide its decision No. NEPRA/R/TRF-100/MFPA/17343-17361 dated 4<sup>th</sup> December 2015 has also allowed immediate application for adjustment in fuel cost component on account of utilization of RLNG under Rule 4(7) of NEPRA (Tariff Standards and Procedure) Rules, 1998 subject to an order of refund for the protection of consumers while the proceedings for devising the fuel price adjustment on RLNG were pending before the Authority.
4. In view of the prevailing shortage of gas and non-availability of furnace oil and in line with the above referred decision, the Authority has decided to allow immediate application of RLNG as alternative fuel in the instant case subject to an order of refund for the protection of the consumers, while the proceedings are pending before the Authority for change in the fuel price adjustment mechanism. The immediate application of RLNG as alternative fuel shall be subject to following conditions:
  - i) The dispatch shall be strictly in accordance with the economic merit order.
  - ii) Operation on simple cycle shall not be allowed.
5. Accordingly, the fuel price adjustment mechanism as provided in Authority's decision No. NEPRA/TRF-255/JPCL-2014/12939-12942 dated 1<sup>st</sup> September 2015 in the matter of motion for leave for review filed by JPCL, stands modified as under:

$$FC_{(Rev)} = FC_{(Ref)} * FP_{(Rev)} / FP_{(Ref)}$$

Where:

FC<sub>(Rev)</sub> = Revised fuel cost component of energy charge part of tariff

FC<sub>(Ref)</sub> = Reference fuel cost component

FP<sub>(Ref)</sub> = Reference RFO price of Rs. 72,897/ton and reference gas price of Rs. 588.23/MMBTU.

FP<sub>(Rev)</sub> = Revised applicable prices of RFO/Gas / RLNG as determined by the relevant agency

6. The reference fuel price and reference fuel cost component on gas and RLNG shall be the same. Other terms & conditions shall remain unchanged.

## ORDER

7. Jamshoro Power Company Limited is hereby allowed, immediate application of RLNG as alternative fuel subject to final decision and an order of refund for the protection of the consumers, while the proceedings are pending before the Authority for change in the fuel price adjustment mechanism. The immediate application of RLNG as alternative fuel shall be subject to following conditions:

- i) The dispatch shall be strictly in accordance with the economic merit order.
- ii) Operation on simple cycle shall not be allowed.

8. Accordingly, the fuel price adjustment mechanism as provided in Authority's decision No. NEPRA/TRF-255/JPCL-2014/12939-12942 dated 1<sup>st</sup> September 2015 in the matter of motion for leave for review filed by JPCL, stands modified as under:

$$FC_{(Rev)} = FC_{(Ref)} * FP_{(Rev)} / FP_{(Ref)}$$

Where:

$FC_{(Rev)}$  = Revised fuel cost component of energy charge part of tariff


$FC_{(Ref)}$  = Reference fuel cost component


$FP_{(Ref)}$  = Reference RFO price of Rs. 72,897/ton and reference gas price of Rs. 588.23/MMBTU.


$FP_{(Rev)}$  = Revised applicable prices of RFO/Gas / RLNG as determined by the relevant agency


9. The reference fuel price and reference fuel cost component on gas and RLNG shall be the same. Other terms & conditions shall remain unchanged.



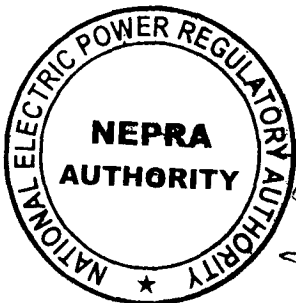


