


**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN THE ENERGY CHARGE
PART OF THE TARIFF RELATING TO FUEL FOR JAMSHORO POWER COMPANY LTD**


Pursuant to the decision of Authority dated April 12, 2018 in the matter of Immediate Application of RLNG as alternative fuel for Jamshoro Power Company Limited (JPCL), adjustment has been made in the fuel cost components of energy charge part of JPCL tariff due to change in RLNG price w.e.f. 3rd May 2018. Oil & Gas Regulatory Authority (OGRA) vide notification dated May 25, 2018 has determined provisional RLNG price of US\$ 11.8726/MMBTU for Sui Southern Gas Company Limited (SSGCL) for the month of May 2018 for its distribution network. SSGCL vide its letter No. CS/JPCL/6/18 dated June 25, 2018 informed to JPCL that the RLNG distribution tariff shall be applied on supply of RLNG to JPCL. The revision has been made on provisional basis and final fuel cost component(s) shall be revised after notification of final RLNG price(s) by OGRA. The block-wise revised fuel cost components of JPCL indicated hereunder shall be immediately applicable to the units delivered during the respective period:


