DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT OF THE NON-ESCALABLE COMPONENT OF CAPACITY PART OF THE TARIFF RELATING TO TAX FOR JPCL.

Pursuant to the Authority's decision dated September 01, 2015 notified vide S.R.O 1142(I)/2015 dated November 17, 2015 in respect of generation tariff for Jamshoro Power Company Ltd. (hereinafter "JPCL"), the Non-Escalable part of Capacity Purchase Price has been adjusted on account of advance tax of Rs. 100,165,000/- paid by JPCL to the Federal Government for 1st Quarter of FY 2018-19 under Payment Section 147 of the Income Tax Ordinance – 2001. This adjustment shall only be applicable for the month of September 2018. The Non-Escalable part of Capacity Purchase Price of JPCL tariff has accordingly been revised, as indicated at Annex-I and shall be immediately applicable.

2. The revised Non-Escalable part of JPCL tariff relating to tax attached as **Annex-I** is to be notified in the official Gazette in accordance with provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.
