Please find enclosed herewith the decision of the Authority along with Annex-I (02 pages) in the matter of adjustment of the Non-escalable Component of Capacity Part of the tariff relating to tax applicable for the month of December 2018 in respect of Jamshoro Power Company Ltd. (JPCL) in Case No. NEPRA/TRF-255/JPCL-2014.

DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT OF THE NON-ESCALABLE COMPONENT OF CAPACITY PART OF THE TARIFF RELATING TO TAX FOR JPCL.


Pursuant to the Authority's decision dated September 01, 2015 notified vide S.R.O 1142(I)/2015 dated November 17, 2015 in respect of generation tariff for Jamshoro Power Company Ltd. (hereinafter "JPCL"), the Non-Escalable part of Capacity Purchase Price has been adjusted on account of advance tax of Rs. 37,062,000/- paid by JPCL to the Federal Government for 2nd Quarter of FY 2018-19 under Payment Section 147 of the Income Tax Ordinance – 2001. This adjustment shall only be applicable for the month of December 2018. The Non-Escalable part of Capacity Purchase Price of JPCL tariff has accordingly been revised, as indicated at Annex-I and shall be immediately applicable.





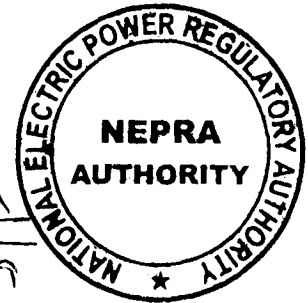
